# PROTECTIVE MEASURES

For emergency responders: Respiratory protection: respiratory protection will be necessary online in special cases, e.g., formation of mists. ### SPILL MANAGEMENT

**Water Spill:** Stop leak if you can do it without risk. Confine the spill immediately with booms. Warn other shipping. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

#### HANDLING
