



## WAIVER OF LIABILITY

To ensure that “V&D Electric Bikes LLC” products are used properly and to ensure that the “Rider” behaves responsibly, this release of liability agreement defines the “Rider’s” obligations, as follows.

### ITEM 1

To ensure that “V&D Electric Bikes LLC” products are used properly and to ensure that the “Rider” behaves responsibly, this release of liability agreement defines the “Rider’s” obligations, as follows:

### ITEM 2

I acknowledge that I have read and understood completely the Owner’s Manual that “V&D Electric Bikes LLC” has provided me. I understand and recognize that the equipment is unfamiliar to me, and it is my sole responsibility to use utmost care and caution when determining where and when to ride the *Go-Bike*, utilizing the guidelines that “V&D Electric Bikes LLC” provides.

### ITEM 3

I agree to be the sole person driving the *Go-Bike* and I am fully responsible for any person or persons who, with or without my consent, sit on or ride the *Go-Bike*. I hereby indemnify “V&D Electric Bikes LLC” for any legal prosecution from physical injury resulting to myself or someone else or property damage from the rental equipment provided by “V&D Electric Bikes LLC”.



## ITEM 4

I hereby release, waive, and discharge the right to seek medical reimbursement or the legal prosecution of “V&D Electric Bikes LLC” for any physical injury (my own or to a third party) or property damage from the use of the rental equipment provided by “V&D Electric Bikes LLC”. It is my express intent that this Release form shall bind my family if I am alive and my heirs, assigns and personal representative(s) if I am deceased. I am aware that the operation of a personal mobility device, such as the “V&D Electric Bikes LLC” *Go-Bike*, has inherent risk by reading, understanding and signing the “V&D Electric Bikes LLC” Waiver of Liability.

## ITEM 5

Regarding the condition of the *Go-Bike* upon Return, the Renter shall return the *Go-Bike* to the designated return area clean and in the same condition as it was in when given to Renter, excepting ordinary wear and tear. Renter shall be responsible for any damage caused to the *Go-Bike* during the rental period.

“V&D Electric Bikes LLC” shall retain a credit card and a valid driver’s license or passport is required for the rental deposit. Your credit card must be authorized by your bank as a deposit in the amount of \$100 per *Go-Bike*. Upon return of the rental items in good condition, we will charge your credit card for the rental amount only; the deposit hold will be released by us.

**NOTE:** The Customer’s credit card company determines when the hold on funds is released; this is typically 2-7 business days.

**IMPORTANT:** If the bike was ever stolen or not returned, a fee of \$2,000 will be retained from the credit card on file. To the extent that damages to the *Go-Bike* exceed the amount of the security deposit, Renter shall be billed by “V&D Electric Bikes LLC” for the full amount of damages caused by Renter during the rental period, including reasonable attorney’s fees.
