

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://leahroling.com>, and Leah Roling and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Leah Roling include <https://leahroling.com> and Leah Roling. The Leah Roling website is a Coaching, Membership, Courses site. By using the Leah Roling website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Leah Roling may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase Leah Roling's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Leah Roling may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Leah Roling collects and uses your personal information to operate and deliver the services you have requested.

Leah Roling may also use your personally identifiable information to inform you of other products or services available from Leah Roling and its affiliates.

Sharing Information with Third Parties

Leah Roling does not sell, rent or lease its customer lists to third parties.

Leah Roling may share data with trusted partners to help perform statistical analysis, send you

email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Leah Roling, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Leah Roling. Use of Cookies

The Leah Roling website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Leah Roling pages, or register with Leah Roling site or services, a cookie helps Leah Roling to recall your specific information on subsequent visits. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
