Academic Needs	Summer School and Before and After school workshops for students identified. A Learning Plan is created for students in quarantine due to close contact and daily academic work and teacher contact are made available during this time.
Social, Emotional and Mental Health Needs	A behavior Analyst has been hired to train teachers and conduct behavioral assessments when necessary. Zones of Regulation, an evidence-based program, will be implemented school wide.
Other Needs (which may include student health and food services)	PPE and rapid tests made available to staff and students.
