

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://bestbodybynature.com>, and Best Body by Nature, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Best Body by Nature, LLC include <http://bestbodybynature.com> and Best Body by Nature. The Best Body by Nature website is a ecommerce site. By using the Best Body by Nature website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Best Body by Nature may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase Best Body by Nature's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ## Use of your Personal Information

## Sharing Information with Third Parties

Best Body by Nature does not sell, rent or lease its customer lists to third parties.

Best Body by Nature may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Best Body by Nature, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

### **Right to Deletion**

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or

- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Best Body by Nature does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

### **E-mail Communications**
