



To threaten someone's livelihood and family welfare unless they do what you say is evil and Satanic in nature. Follow the example of Daniel and stand for what you know is right.


3. Without Push-Back This Will Never End

TO VAX or not to VAX

THAT IS THE QUESTION

L

et me preface everything that follows with a very simple and honest statement: I am not anti-vaccine. In fact,

I am quite "pro-vaccine", and have spoken and written prolifically on the importance of vaccines in the past. There are times when vaccine requirements make good sense based on solid scientific evidence and prudent public health policy; times when the risks of life-threatening infection are otherwise far too high, and the availability of treatments far too low; times when the data are overwhelmingly in support of mass vaccination following prolonged study and testing. But to quote Thomas Paine, these are the times that try men's souls...

Manipulating the immune system is tricky business, and the body's response to vaccines isn't always readily apparent or predictable. It takes detailed and extensive testing to determine both the efficacy of a vaccine in preventing illness, as well as its safety in both the short and the long term. Historically, it has taken an average of 4 to 6 years for a vaccine to come to market, if it ever makes it at all; there are many, many viruses for which scientist have never succeeded in creating a safe and effective vaccine.

As with all medical treatments and interventions, the decision to take a vaccine should be done only after thoughtful and well-informed risk-benefit analysis. That means an individual must understand his or her true risk from a disease or illness, and weigh it against the potential risks and benefits of the treatment or intervention. Unfortunately, for the duration of the COVID19 pandemic, it has been nearly impossible for people to access the information necessary to make this critical calculation for themselves and their families. Rather than providing objective, scientific data on the actual risk from the virus and the potential risks from the vaccine, the media and public health officials have opted to instill fear and anxiety in the population in hopes of swaying people's healthcare decisions. Their biased reporting has

caused the vast majority of people to vastly over-estimate their personal risk from the virus, while underestimating their risks from the vaccine itself. They have refused to report on simple and successful prevention techniques, as well as the many safe, effective and readily available early treatment options. They have ignored the importance of "natural immunity" - the broad, robust and enduring protection that the millions of people who have had and recovered from COVID clearly possess. Without access to the information necessary to make an educated risk-benefit calculation, Americans have tragically been coerced, shamed, ridiculed and now mandated to take a vaccine that may not be medically necessary or in their best interests.

In reality, *most* people have a very low risk of serious infection or death from COVID19. In nearly every country, including the United States, the average age of death from COVID is actually higher than the life expectancy - Meaning that this is largely a serious disease in the elderly. Other than advanced age, the single greatest risk from COVID is obesity, followed by diabetes and heart disease. Healthy children have a nearly zero risk from COVID; while they can contract the virus, they rarely become significantly ill and furthermore have been shown not to spread the virus to others. Based on the CDC's own statistics, generally healthy people under the age of 50 have no greater risk from COVID than from influenza. Furthermore, with more than 20 months of experience behind us, doctors have developed a very safe, effective, inexpensive and readily available treatment protocol, if and when one contracts the virus. Simple interventions such as supplementing Vitamin D and taking zinc, along with regular exercise, adequate sleep and stress management can profoundly decrease the risk of ever contracting COVID, yet public health leadership has been strangely silent on these issues.

To date, there have been nearly 44 million confirmed cases of COVID19 in the U.S. The CDC estimates that there have been as many as 5 or 6 times that number of actual cases, however, which means that more than 225 million Americans have likely had and recovered from the virus. Multiple studies have shown that these individuals now have strong protection against COVID – at least as good, if not better, than the immunity gleaned from the vaccines. This is consistent with our experience with other similar viruses, including SARS-CoV1 in 2003; people who had and recovered from that virus still have powerful immunity today, 18 years later! There is no scientific rationale for COVIDrecovered people to be vaccinated, and there is mounting evidence that they may, in fact, have a higher risk of adverse reactions if they are.

As of this writing, there are three COVID19 vaccines available in the United States: Moderna, Pfizer and Johnson& Johnson. In an effort to rush these vaccines to market, all three underwent very minimal testing, with highly accelerated clinical trials. All three were released with an Emergency Use Authorization only, not an FDA approval. Large groups of people were not included in the limited testing that was conducted; pregnant women, lactating women, people with underlying auto-immune diseases, children, cancer patients and those who had already had and recovered from COVID were purposely excluded from the trials. The long-term safety profile of these vaccines, including the potential impact on the neurological system, fertility, or the development of cancers and auto-immune diseases remains completely unknown. None of these vaccines were in existence a


year ago, so there simply hasn't been adequate time to evaluate their medium and long-term side effects. In contrast, routine immunizations such as measles, mumps, rubella, chicken pox and polio that are commonly required for children to attend school, or for people to serve in the military, have *decades* of testing and safety data behind them.

Importantly, the current COVID vaccines utilize technology that has not been used successfully in vaccines previously. Traditional vaccines use weakened or killed virus to stimulate an immune response. Instead, the Moderna and Pfizer-BioNTech vaccines use mRNA, genetic material that ultimately instructs the body to produce one of the spike proteins found on the outside of COVID19, in hopes that the individual will then manufacture antibodies against that same spike. For more than a decade, scientists have worked to create a safe and effective vaccine utilizing mRNA, however they have always failed during the testing period with sometimes disastrous results. The [&] COVID vaccine does something similar, but uses a harmless virus to deliver the genetic "instruction manual" for the production of the spike protein. The [&] vaccines were produced or validated with the aid of fetal cell lines, to which people with certain religious convictions may strongly object.

In addition, the COVID19 spike protein is highly pathogenic – capable of producing disease -- on its own, and the danger presented by introducing this protein into the human body cannot be overstated. Studies have shown that the vaccine does not remain at the injection site in the shoulder, but actually migrates to multiple different organ systems, including the lungs, heart, kidneys and intestines, with significant amounts concentrating in the reproductive organs. Worldwide, we have seen a worrisome incidence of blood clots, heart inflammation, neurologic symptoms and fertility issues following vaccination with all three of these vaccines. Without adequate testing and long-term safety data, it is simply impossible to know the extent of potential harm from the vaccine-induced production of spike proteins.

Lastly, the "efficacy" of the current COVID19 vaccines has proven to be far less than was predicted. While we were initially told that the vaccines were upwards of 95% effective





in preventing infection, in less than 6 months we have seen a precipitous fall in that number and an increasing number of breakthrough infections amongst the "fully vaccinated". As a result, the drug manufacturers and public health authorities are recommending boosters, the number, frequency and side-effects of which are completely unknown. The vaccines are now being touted as able to "decrease the severity of the illness" rather than to prevent actual infection. Given that vaccinated people can clearly still contract and transmit the virus, it begs the rationale for in any way discriminating between the vaccinated and the unvaccinated.

Ultimately, the decision to take a COVID vaccine should remain an individual one, based on that individual's personal health history, risk factors, previous COVID infection and religious beliefs, respecting that no two people's risk-benefit calculations are identical. Given the low risk of serious infection for the majority of the population, the large percentage who have existing natural immunity, the availability of safe and effective early treatment options, and the paucity of both short and long-term safety data on the vaccines, mass vaccination and vaccination mandates are both unnecessary and unwise. We have suffered as a result of this virus for far too long; it's time we stop suffering from unnecessary mandates that defy the science and deny individual freedom of choice based on an informed, well-reasoned risk-benefit analysis. To further quote Thomas Paine, Heaven knows how to put a proper price upon its goods; and it would be strange indeed if so celestial an article as FREEDOM should not be highly rated.

Christians, Vaccines, & Religious Exemptions

merican Christians are facing an attack upon their faith that hasn't been seen in America since the 1700's. Christians are being told that they must choose between their jobs and their faith. Church leaders

are arguing that freedom of conscience is not a Biblical principle. We might say as Thomas Paine said in 1776: "These are the times that try men's souls."

The good news is, despite what those in government might mandate or what those in a pulpit might preach, America was built upon the fundamental principles of individual liberty, freedom of religion, and the right to live according to the dictate of one's conscience. The bad news is, too many Christian Americans do not know these facts and do not possess the knowledge that delivers the courage to stand for their God-given rights. The people perish for lack of knowledge.

What do Christians do when employers, the government, or schools demand taking the shot when doing so would violate sincerely held religious beliefs? Do Christians have to submit? Can they refuse to comply? Our Constitutions and our laws support a Christian's right to say no; and American Christians need to know why and how.

Is the Bible a Credible Argument Against Taking the Shot?

First, it is now common knowledge that all three of the currently available COVID-19 vaccines are derived from, manufactured with, tested on, developed with, or otherwise connected to aborted baby cell lines. As confirmation to this fact, a Pfizer employee recently became a whistleblower when she reported internal Pfizer documents and communications to Project Veritas. In these internal Pfizer documents are detailed accounts of the Vice President of Pfizer and his employees admitting to the use abort baby cells, and actively engaging in practices to attempt to keep this information from the public. This ought to tell the American Christian that Pfizer knows that the American people will have a problem with the use of aborted baby cells and to protect their product they are willing to actively hide that information from the public.

A Bible-believing Christian ought to have a sincerely held religious belief that abortion is the murder of human beings and murder is a sin. Therefore, every Bible believing Christian ought to hold a firmly held religious objection specifically against any vaccinations resulting from the research or use of aborted baby cell lines.

However, there have recently been an influx of religious leaders promoting their opinion as gospel that it's not only ok to take these vaccines but also the "Christian thing to do." One such argument was presented by Southern Baptist ethicist Russell Moore. In his article, Moore claims that the fact that these shots are made using aborted baby cell lines does not equate to "sin." Moore asserts that the abortions from which the research is derived happened so long ago that believers have a "sin protection." In other words, time has washed away the sin of murdering babies for research purposes and drug production.

Moore may believe that his "ethical analysis" is the standard for all Christians, but a clear reading of the law and of Scripture beg to differ. As a matter of fact, it is not legally proper for Moore, your employer, or the government to determine whether an individual has a correct understanding of religious doctrine or whether an individual's sincerely held religious beliefs are shared broadly among members of a faith. As the Supreme Court has recognized, someone's "religious beliefs need not be acceptable, logical, consistent, or comprehensible to others in order to merit First Amendment protection." Thomas v. Rev. Bd. of Ind. Emp. Sec. Div., 450 U.S. 707, 714 (1981). See also Church of the Lukumi Babalu Aye, Inc. v. City of Hialeah, 508 U.S. 520, 531 (1993) (same). Additionally, it is also not necessary for anyone to hold membership in or adherence to the tenets of an organized religion to have a credible claim for exemption. See Frazee v. Ill. Dep't of Emp. Sec., 489 U.S. 829, 834 (1989). Again, the Constitution and the law provides protection for everyone's sincerely held religious beliefs even if some members of the same religious organization, sect, or denomination disagree. Moreover, the denial of anyone's request for a religious accommodation and exemption based upon the views of other individuals who disagree is unlawful. It is legally irrelevant what other individuals think or religiously believe. Once someone has articulated their sincerely held religious objections to acceptance of the currently available COVID-19 vaccines, the proper inquiry is over.

Another errant argument has been promoted by another self-appointed gatekeeper, Robert Jeffress. "There is no credible religious argument against the vaccines," Jeffress claims, because other medications like Tylenol, Pepto Bismol, or Ibuprofen may have also been created using aborted baby cells. What if a Christian does not take the drugs on this list? Would Jeffress change his mind about the credibility of the Christian vaccine objection?

Land of the Free Home of the Brave While some people may hold sincere religious beliefs against taking ANY vaccines, many others only hold religious beliefs against accepting those vaccines derived from aborted fetal cell lines used in testing, development, or manufacturing. Some past vaccines were derived using aborted fetal cells, some weren't. Some medicines were derived from aborted baby cells, some weren't. Many people were unaware that ANY were based on these cells but are discovering so now.

To make relevant someone's past medications or vaccinations is like asking someone to say "yes" to a question of "have you ever smoked tobacco," and say he has no basis or right going forward, to be a "nonsmoker;" or if one has ever had (or coerced someone else to have) an abortion, one can no longer oppose abortion and truthfully claim to be "pro-Life" going forward.

Jeffress's proclamation is an attack on millennia of Christian theology of "repentance" and turning from sin, as set forth in 1 Corinthian 6:9-11. Every born-again Christian knows the Bible is set upon the foundation of God's power to bring new wisdom and change the heart of man, but Jeffress's premise presumes otherwise. Thus, questions regarding past vaccines or other drugs are what lacks credibility. Jeffress's argument also violates all liberties of First Amendment and many other rights. Perhaps Jeffress does not support God's power of conviction, repentance, or forgiveness? At best, one might argue that a person is inconsistent in their belief. Yet that does not preclude anyone else's right to object just because someone else decides to take Pepto Bismol!

Regardless of what Moore, Jeffress, or the Pope might say, our Constitutions and the law both support every individual's right to refuse to take these vaccines according to their sincerely held religious objection. Self-proclaimed Christian Belief Dictators don't get to decide for us.

A Christian's Sincerely Held Objections

Christian business owners ought to know they also have the right to refuse to mandate these vaccines upon their employees with the same Biblical and legal justifications as their employees. If a Christian has a sincerely held religious objection to the vaccines, it is then reasonable and within their right to say, "No." In that same respect an employer has the right to say: "To mandate these vaccines upon my employees would violate my sincerely held religious beliefs, so I will not force my employees to take the vaccine in order to keep their jobs."

If a Christians has an objection to the use of aborted babies for research or drug production, then they have the right to declare their religious objection and every Christian employer has the right to refuse to enforce these drugs upon their employees. If a Christian believes that any mandate that restricts his ability to completely trust and depend upon Jesus Christ for healing and divine health is a conflict of his faith, he has the right to assert his religious objection.

A person may believe, the antichrist system will force certain things upon people by restricting the ability to buy or sell unless they cooperate and comply with coercive dictates. They may believe that the vaccination mandate is part of, or precursor to that system because it restricts a person's ability to buy, sell, or engage in their profession under threat of force. Therefore, if someone believes the Scriptures justify them to not participate in such mandates, they have a right to stand for their religious beliefs and refuse to take the vaccine, and it does not matter whether anyone agrees with him or not. The liberty of individual conviction is the core of religious liberty.

According to the law, once someone asserts their sincerely held religious objection, their employer, the government, or school must then offer "reasonable accommodations" unless the employer, the government, or school can show that to do so would cause "undue hardship." What is legally important to understand is that the standard is not "absolutely no hardship" and the burden to prove "undue hardship" rests up the one mandating the vaccine, not the Christian asserting their right to religious exemption.

What If They Deny or Ignore An Objection?

These are the legal facts according to our Constitutions, Title VII, the Civil Rights Act of 1964, and many State laws. The final question that must be answered is, what if you have a government so bent on forcing an agenda upon Christians that they will willfully violate our Constitutions and the law and use corrupt courts to support these violations? That's when Christians must know that their rights to freedom of conscience and control of their own body are God-given rights not a government granted privileges. With every legal argument we make to defend our rights, the enemy comes up with an excuse to overturn our argument. Religious exemptions are not a permanent fix, they are a temporary measure to allow people the time to get their houses in order and stand in the face of lawlessness. The day is quickly approaching when religious beliefs will no longer be tolerated. Knowing that God is the source of our Rights is essential in knowing how and why we must defend them.

The fact that our rights are God-given shouldn't be a matter of debate. The Declaration of Independence, our first foundational document as independent States, has as it's opening statement: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights..." The Constitution of the United States and every State Constitution both affirm these God-given rights. The day is rapidly approaching where every Christian will have to declare their allegiance: to the God of Heaven or the Antichrist system. Americans will have to decide, do they stand for their God-given Rights, or do they surrender to fear and the need for comfort. If a person truly knows that their rights come from God and not from government the choice will be much easier. If a Christian truly knows that God is their provider and their comforter, then fear will not prevent them from the stand that will ultimately keep their children from being enslaved.



you have to cry through it in the beginning.

Communication might also feel sacrificial to you because it can mean bearing your soul to your spouse. Do it anyway. Practice the art of communication because your spouse cannot read your mind.

I used to think if I slammed something, or shut the door hard enough, Jonathan would know I was upset. Now I know it's impossible for him to read between the lines! I had to communicate what bothered me. Only after I communicated effectively could we move forward.
