AGREEMENT OVERVIEW

This agreement contains the entire understanding between the Client and 28 North Photography and supersedes any previous written or oral agreements.

EXCLUSIVITY

It is understood that 28 North Photography will be the sole and exclusive wedding photographer. This does not prohibit videographers, photobooths, or invited guests who bring cameras.

PERMISSIONS

All permits and permissions required for the Photographer to photograph the event (and "Engagement Session", if applicable), whether for location, personal release or any other cause, are the responsibility of the Client to obtain.

RESPONSIBILITIES

28 North Photography is not responsible for compromised coverage due to causes beyond its control including but not limited to obtrusive guests, lateness of the Client or guests, weather conditions, schedule complications, incorrect addresses provided to it, rendering of decorations, or restrictions of the locations. 28 North Photography is not responsible for backgrounds or lighting conditions that may negatively impact or restrict the photo coverage. 28 North Photography will not be held accountable for failure to deliver images of any specific individuals or objects at the wedding.

CAPTURE & DELIVERY

28 North Photography is not liable to deliver every image taken at the event. The determination of images delivered to the Client is left to the discretion of 28 North Photography. The final post-production and editing styles, and overall look of the images are left to the discretion of 28 North Photography. Once the photos are delivered via the online gallery, the Client is responsible for their safety via downloading and backing them up.

REPRODUCTION

All images provided to the Client are copyright 28 North Photography. 28 North Photography grants the Client permission to share the unaltered images with friends and family. 28 North Photography grants the right to the Client to print the photographs using any professional print vendor.

MODEL RELEASE

The Client hereby assigns 28 North Photography the right to use and publish photographs of the Client for advertising or any other purpose and in any manner and medium. The Client releases all claims to profits that may arise from the use of images.

LIMIT OF LIABILITY

In the unlikely event that 28 North Photography is unable to perform to the guidelines of this contract due to an injury, illness, Act of God, force majeure event, or other cause beyond its control, 28 North Photography will make every effort possible to secure a substitute professional photographer. The substitute may also come with an offered lower fee amount and/or adjustment to the Client's choice of services. If the Client defers the substitution offer, they may elect instead to terminate this agreement subject to the following: 28 North Photography shall refund all payments made by the Client including a full refund of the 50 percent retainer. 28 North Photography's responsibility and liability are limited to the return of all payments received for the wedding.

POSTPONEMENT

If the event is postponed due to an Act of God, such as terrorist attack, hurricane, tornado, flood, forced evacuation, fire at the wedding site, etc, then 28 North Photography shall make every effort to photograph the event at a future date that is reasonable for both 28 North Photography and the Client.

TRANSFER

This agreement cannot be transferred or assigned to any third party by either 28 North Photography or the Client without written consent of both Parties.

PAYMENTS

The Client shall reserve the time and date of services by signing and returning this Contract along with a non-refundable, non-transferable Retainer payment referred to above as "Initial Payment". No date is reserved until the signed Contract and Retainer are received. Upon receipt, the Photographer will reserve the Event Date and will not make another reservation for the agreed-upon time. For this reason, the Retainer is non-refundable. 28 North Photography is not responsible for the rendering of services until the "Total Amount" listed above is paid. In the event the Client fails to remit payment as specified, 28 North Photography shall reserve the right to immediately terminate this Contract with no further obligation, retain any monies already paid, and not attend the event. Unless the Contract is canceled, the Retainer shall be applied to the photography fee total.

CANCELLATION
