In conjunction with my participation, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: Bucks County, Bucks County Horse Park Inc.; members; landowners; Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), and competition managers; the promoters, sponsors, or advertisers; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
