_____ **Exhibit "D"** Pursuant to Section 97.13(B)(2)(f), if Applicant is proposing to install new poles within the Rights of Way, the Applicant shall provide, the location, size, color, material of the proposed poles and that Applicant will adhere to all applicable Laws concerning the installation of new poles.

_____ **Exhibit "F"** Pursuant to Section 97.13(B)(2)(i), Applicant shall provide: a preliminary construction schedule and completion date.

_____ **Exhibit "G"** Pursuant to Section 97.13(B)(2)(j), Applicant shall provide payment of: all money due the City for Permit Fees; and any loss, damage, or expense suffered by the City as a result of Applicant's prior Construction in the City Rights of Way or any Emergency action taken by the City; any Certificate of Registration issued to Applicant or Person for whom Facilities are being Constructed; any other money due the City from Applicant or Person for whom Facilities are being Constructed.

_____ **Exhibit "H"** Pursuant to Section 97.13(B)(2)(k), when a Construction Permit is requested for purposes of installing additional Systems or any part of a System, the posting of a Construction Bond and Removal Bond in accordance with Chapter 97.17 and acceptable to the Village **may be** required.
