2023 Breeding Agreement For R Blue Moon EARLY BOOKING/RETURNING BREEDER

This shipped Semen Contract is for the Season of 2023, is made and entered into on this day of _____ by and between Lisa Martin-Gerdes hereinafter referred to as “Stallion Owner” and _____ hereinafter designated as “Mare Owner.” The Mare owner agrees to breed the mare _____ Reg. # _____ to the Stallion Blue R Moon subject to the following:

1. The Stallions Fee's shall be \$850 (includes: 2yr live foal guarantee, 1st Collection, booking and handling) of which \$200 shall be considered as a non-refundable booking fee (due with contract). The remaining balance shall be paid prior to the first collection/shipment.
2. The Stallion Owner will make all reasonable attempts to ship the semen in a timely manner and requires a minimum of 24 HOURS notice prior to collection and shipping. At this time there is no Sunday carrier pick up and Saturday Delivery may not be available in your area.
3. A Collection Fee of \$350 will be charged each time the semen is shipped. The Mare Owner is responsible for all collection and shipment fees. The mare owner must provide or obtain their own FEDEX account number, unless other-wise agreed. Call 1-800-Go-FEDEX to obtain a free shipping account number.

4. If more than one collection is required to settle the mare, the mare owner is responsible for all Collection and Shipping Costs.

5. Guarantees: Live Foal (2yrs)

6. Live foal shall be defined as one that stands and nurses without assistance. Should the foal not stand and nurse, the mare owner agrees to notify the stallion owner within one week of the foaling date and furnish a statement from a licensed veterinarian. The mare owner will be entitled to return the same mare for a re-breed provided the stallion is living and fit for service. If the stallion dies or becomes unfit then this contract shall become null and void.

7. A "Breeding Certificate" will be issued for the foal conceived from this mating provided all fees and other expenses have been paid in full and when the mare has produced a live foal. The mare owner assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury or infection or any reason whatsoever and agrees to hold the stallion owner/manager harmless for any and all damages therewith.

8. This contract is non-assignable and non-transferable without prior written consent of the stallion owner.

9. This contract is entered into in the State of California and will be interpreted and enforced under the laws of that state.

10. This contract represents the entire agreement between parties. No other agreements or promises verbal or implied are included unless specifically stated in this written agreement/contract. Additional conditions should be written on this contract and initialed by each party.

11. A Copy of this Agreement will be returned to you upon Receipt of your Signed Contract and Booking Fee.
