# **Privacy Policy**

This Privacy Policy ("Policy") applies to divinedesignit.com, and Divine Design It ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include divinedesignit.com. The Company's website is a website development services site. ### **Collection of your Personal Information**
