Rules & Information

1. The Landrum Farmers Market (LFM) functions as a “producer’s market.” This means that to participate as a vendor, you must grow, cook or produce your product.
2. As a vendor, you agree to allow Market Directors to visit your farm, kitchen, or craft area for inspection.
3. All vendors are required to be in compliance with state laws and permitting regulations, specifically SC Law 44-1, commonly referred to as SC Cottage laws.
4. Resales of produce purchased from others, yard sale items, resale of food items, **is not allowed.**
5. Vendors who operate and sell Community Supported Agriculture (CSA) shares are not allowed to sell or allow pickup of their boxes at the market.
6. Craft vendors will be limited to 20% of the total number of vendors at the market. Ten (10) craft vendors will be allowed each week. Crafters applications will be limited to 80 applications.
7. At all times, farm producers take priority for space at the market. This means that craft vendors or food producers may lose their space during peak market season.
8. All Vendors over the age of 16 selling at the LFM are required to purchase and obtain and/or hold a current Landrum Business License. These are good through April of the following year.
9. All Vendors selling at the LFM are required to complete a LFM Vendor Application & Certification form.
10. Applicants will be classified as Farm Producer, Food Producer or Crafter based upon the Application & Certification form.
11. Dates for the 2026 Regular Market Season are Saturdays, April 4th until Saturday, October 31st, rain or shine.
12. The Market will open to Vendors at 7:00am to begin setup.
13. Customer hours for the 2026 Market Season will be 8:00 am – Noon.

14. Vendor Parking will be on a RESERVED basis. Only 1 truck or automobile is allowed in each parking spot. Vendors with inside spaces are allowed to pull-in and unload but must move automobiles to the parking area as soon as possible. Please park in the grassy field on days we don't have an event in the field.

15. Fees for the 2026 Market will be as follows:

Farm Producer	\$15.00 per week
Food Producer	\$20.00 per week
Crafter	\$20.00 per week
Under 16 years old	\$10.00 per week

16. Vendors who find that they will miss a Saturday market are required to call, text or email the Market Directors 24 hours in advance of the market so that the space can be filled.

17. Vendors are encouraged to stay for the full duration of the market (8:00 am – Noon). Vendors who sell out of items are not required to stay the full time. Please pick up a sold out sign if you leave early.

18. Vendors will not be allowed to sell live animals.

19. Pets will be allowed if on a leash and provided that owners clean-up any waste made by the pets. If you plan to bring a pet, please review our pet policy on our website. (landrumfarmersmarket.com)

20. Vendors assigned pull-in spaces must provide their own tables for their goods. Electricity is provided at every other pull-in spot.

21. Vendors with table spaces(35-58) will be provided, 1 – 6' table for your use.

22. All Vendors are responsible for clean-up of their individual spaces at the end of each Saturday market. This could include the moving and storage of inside tables used, sweeping and/or mopping.

23. Only one vendor will be allowed at a ten by ten space per week.
