Deposits + Payments

For projects paid in full upfront, 30% of the total is considered non-refundable if the project is canceled by the client before work begins.

No refunds will be issued once design work has started.

Cancellations

If you need to cancel your project before any work has started, please notify me in writing at least 5 business days before your project start date.

If the project is canceled after work has begun, no refunds will be given. You will be invoiced for any work completed beyond the initial deposit.

In the case of a client becoming unresponsive for 14+ consecutive days without communication,

the project will be considered abandoned. In this case, Shawna Fay Design Studio reserves the right to terminate the project, and all payments made will be forfeited.

Refunds

Due to the custom nature of branding and web design services, no full or partial refunds will be issued for completed or in-progress work.

If for any reason Shawna Fay Design Studio must cancel a project (due to personal emergency or other unforeseen issue), a partial refund will be provided based on work not yet completed.

Rescheduling

If you need to reschedule your project start date, please reach out as early as possible. I will do my best to accommodate your needs based on current availability.

Final Delivery

Final files or website transfers will only be delivered once the full project balance is paid in full.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted.
