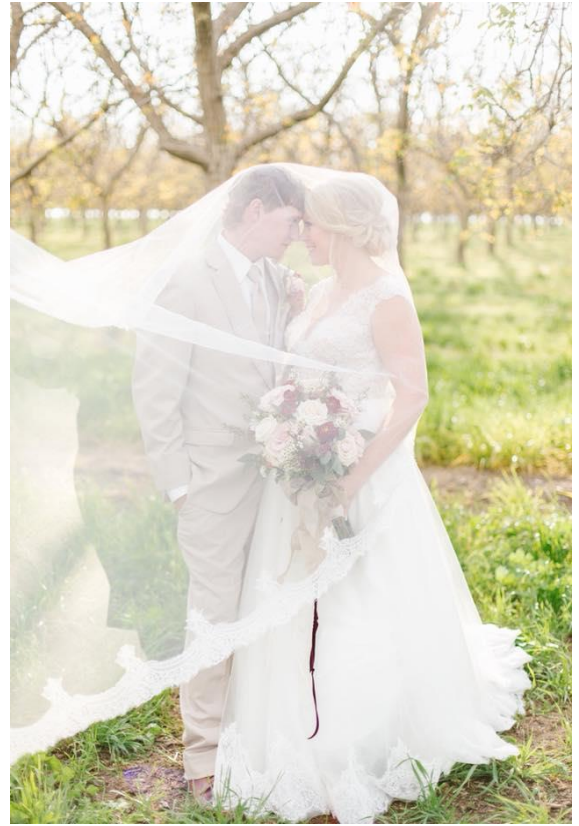
WHO

ALCOHOL

You are welcome to have alcohol at your event. We only allow aluminum cans, please NO GLASS. If providing your alcohol for your event you will need the following. It is the client's responsibility to purchase the event insurance policy if providing your own alcohol for any event. You will need to hire our 2 Bartenders that will be required to check guest identification, ensuring that only those over 21 are being served. We also have a fully stocked licensed bar for service. Ford Farms reserves the right to shut down the bar at any time and will be not responsible for any refunds should this occur. Drunken and/or violent disturbances are prohibited and subject to immediate removal from the premise and possible termination of event without refund. CLIENT ASSUMES ALL RESPONSIBILITY FOR GUESTS AND ALCOHOL RELATED INCIDENTS WHILE ON AND OFF THE PREMISES.

CANCELLATIONS

In the event of a cancellation of a special event or wedding, all payments that have been made to date are non-refundable. If wanting to reschedule your event date, We will apply all payment amounts that have been made towards any open available date up to 1 year from signed contract date.

CATERING

We invite you to choose your own caterer or use our inhouse caterer.

CHILDREN

All children under the age of 18 must be supervised always.

CLEAN UP & TRASH REMOVAL

Trash removal is included in our package; however, it is the client's responsibility to ensure that all personal belongings (additional decorations, rentals, centerpieces, dishes, etc.) be removed from the tables after the event, and that any rentals are broken down according to specific vendor specifications.

DATE CHANGES

In the event the client(s) is forced to change the date of the event or wedding, every effort will be made by Ford Farms to transfer reservations to support the new date. The client(s) agrees that in the event of a date change, any expenses (including but not limited to deposits and fees that are non-refundable and non-transferable) are the sole responsibility of the client(s). The client(s) further understands that last minute changes can impact the quality of the event and that Ford Farms is not responsible for these compromises in quality.

DÉCOR/EVENT LIMITATIONS

Ford Farms reserves the right to limit items used during your event at the discretion of its owners. We expressly prohibit the use of any of the following:

- We DO NOT ALLOW confetti or any other confetti-like artifacts or loose glitter.
- We only allow thumb tacks, removable sticky strips, fishing line & push pins for décor. NO NAILS OR STAPLES

DEPOSIT/PAYMENT TERMS

A non-refundable deposit is required to reserve your date. deposit will be applied towards the venue rental fee and the remaining amount is due up to 5 days before event. A date is not considered booked until a signed contract and deposit are received. Acceptable forms of payment include cash and checks. All checks should be made out to Holly Ford and can be mailed to 22827 Road 180 Lindsay, Ca 93247. In addition, a credit card number must be placed on file to cover incidentals. Payments may be made and applied to the final balance at any time.

INSURANCE

Clients are required to purchase a one day, \$1 million general liability event insurance policy for all wedding events. This can be secured through your own insurance provider or through a third party. Ford Farms requires that proof of this policy be on file no less than 30 days prior to the event date.

PARKING

Ford Farms can accommodate up to 200 guests in the parking area. We can also accommodate limos, trailers, and other large vehicles. Ford Farms is not responsible for items left in vehicles, stolen vehicles, or other personal property claims. Ford Farms will not be held liable for any damages to vehicles that occur while on our property.

REHEARSAL

A two-hour rehearsal time is included in your package. Rehearsals are held on Thursdays or Fridays preceding the event date. These are scheduled on a 'first come, first served' basis.

SECURITY

We will provide security for your event to ensure a safe & fun environment for all.

SMOKING POLICY

Smoking is permitted only in the designated outside areas near the bon fire pit. Any smoking related litter or damage will be considered an incidental. The credit card on file will be charged accordingly to cover additional clean up and/or repair costs. Weather Conditions In case of inclement weather, Westwood Barns staff will do everything we can to accommodate your event. Tents may be rented and brought onsite by the client, but they may only be set up in specific areas. If tents are rented, the client must notify the venue within 72 hours of their scheduled event date or service charge will be charged to the client to cover the cost of rearranging the venue to accommodate the tent. Ford Farms will be not be held liable for any damage occurring to rentals or personal items, or for the cancellation of an event, due to unforeseen and unavoidable weather circumstances.
