

# Taekwondo Manitoba Coaching Policy

# **Section 1 - Policy and Guidelines**

#### 1) Policy:

This policy sets forth standards and guidelines for coaches within Taekwondo Manitoba (TM), aimed at promoting professionalism, athlete safety, and ethical conduct in the sport of Taekwondo.

#### 2) Certification and Training:

- i. NCCP Certification
  - a. Starting 2026, all coaches are required to maintain current certification through the National Coaching Certification Program (NCCP), appropriate to their coaching level.
- ii. Specialized training
  - a. Coaches must complete TM Coaching Standards, focusing on professional development to serve and support Manitoba athletes effectively.

#### 3) Registration and Membership:

Coaches must register annually with Taekwondo Manitoba and Taekwondo Canada, ensuring their membership is current.

#### 4) TM Minimum Coaching Standards:

Effective February 1, 2024, these standards are designed to guide coaches through their professional development.

# **Coaching at National or International Events**

As per Event Coaching Requirements.

NCCP PC certification or ACD (Advanced Coaching Diploma) is equivalent.

#### **Note**

NCCP PC certification or ACD (Advanced Coaching Diploma) is equivalent. Exemption for out-of-province (non-Manitoba residence) coaches applies for 2024 & 2025.

Starting 2026, AI or equivalent certification is required for all coaches.

## 5) Coaching Fee Structure:

2024 Season: No charge for coaching registration to facilitate transition.

2025 Season and Beyond: Fees to be determined by the board of directors.

### 6) Policy Review and Updates:

The policy will undergo regular reviews and updates in line with evolving best practices and regulations.

Compliance is mandatory for all Taekwondo Manitoba coaches. Non-compliance may result in disciplinary actions, including coaching privileges revocation.

An up-to-date database of coaches will be maintained on the TM website.

This policy ensures that all athletes in Manitoba are coached by qualified individuals, promoting safety and fair competition.
