After the Gazette article was published 5/29/21, Mr. Wright met with foster parent leadership to explain his side of the story. Mr. Wright explained that Ms. Ballage's claims discrimination are unfounded because Ms. Ballage wrote a glowing resignation letter.

This statement contradicts the email that was sent to Hope and Home foster families in May 2021, prior the Gazette article publication, in which it stated, "We were surprised by this [lawsuit] being that this particular employee left the organization with well-documented and unsolicited rave-reviews of her time as an employee of Hope & Home."
