Terms & Conditions

BOOKINGS: To secure a date, a signed contract and a deposit of _____ are required. This deposit is non-refundable and non-transferable. This deposit will be put toward the client's total wedding day balance if the client chooses wedding day services. The remaining balance will be due as soon as makeup and hair styling service is completed. Please note that bridal consultations and deposit fees are two separate costs.

TRIAL / CONSULTATIONS: Consultations are available for brides as well as their bridal party members, including but not limited to: bridesmaids, mothers of the bride and groom, grandmothers, extended family members, guest speakers, etc. I recommend that additional consultations should be scheduled on the same day as the bride's consultation in order to avoid an additional travel fee.

LIABILITY: All brushes, tools, and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist <your name here > from liability for any skin complications due to allergic reactions. Also due to this clause, I am not able to tweeze or razor eyebrows.

DELAYS: I will create a schedule for the day, and will send this by email to the Bride for review. The list of girls receiving services is due two weeks before your wedding. Please include full name & all services needed. A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if the scheduled makeup application exceeds the allotted time due to client delays

SATISFACTION GUARANTEED: Makeup and hair styling will be completed to the client's satisfaction, and acceptance of the completed makeup application is acknowledgement by the client that the makeup and hair styling is done to the client's satisfaction.

PARKING FEES: Where parking, valet or toll fees may be incurred. This amount will be included in the final bill and will be due on the day of the event.

TRAVEL FEES: Travel within 25 miles of Owensboro is completely free of charge. A mileage fee (\$0.75/mile both ways) will be charged for locations outside of the 25-mile radius of Owensboro, KY 42301. Travel fees apply for all pre-event makeup consultations as well as day-of appointments.

PAYMENT: The final balance is due 1 week before the date of the event. This is to make your special day go smoothly so everyone is accounted for. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this contract.

SOCIAL MEDIA & WEBSITE: Photos taken at the trial or your professional photos may be used as examples of my work for future clients to view. Your photographer will receive proper credit for their work. You agree to me using these photos, as well as give consent to using your professional photos on my website/portfolio/social media. I will email you to request these photos and will also reach out to your photographer.





Terms & Conditions...

SERVICE LOCATION & REQUIREMENTS: The location of makeup and hair styling services for the day-of-event will be at the Bride's discretion, but there are certain requirements the artist will need to complete the services. A set-up table/work area/chair/trashcan/outlet if using airbrush will need to be made available for the Makeup Artist. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. Artist will arrive 15 minutes prior to set-up. Please communicate the hotel room number if applicable by email or text.

CANCELLATION POLICY: Your booking is a reserved spot. If you decide to cancel your wedding day services, you will not receive a refund of your deposit. If you cancel with less than one week before your wedding, you will not receive back the deposit or final payment. All cancellations must be submitted communicated in written form either by email or text.

I, _____, understand and agree to pay the non-refundable security deposit to secure the appointment(s) for my bridal party and myself. I agree to pay the complete balance for my party one week before the wedding date listed in this contract. I understand and will comply with all policies as listed in this contract. I understand that no refunds will be given for members of the wedding party who miss their appointments on the day of the wedding. I also understand that I am responsible for any extra services, any members of my party may add the day of your wedding such as lashes, or a additional family member needing makeup or hair services.
