TERMS AND CONDITIONS

The Purposeful Professional

As part of the program, you have access to pre-recorded video training sessions, which can be completed at your own pace and 12, 60 minute, one to one, online hypnotherapy sessions that will be pre-arranged to take place Monday to Friday at 8pm (UK time) or on Saturday and Sundays, with various time slots available. Time slots outside of these are available on an ad hoc basis and cannot be guaranteed.

Booking Hypnotherapy Sessions

To book a hypnotherapy session, you must contact Stacey Barber and arrange a suitable date and time.

Hypnotherapy sessions will be conducted in a safe, confidential, and professional manner.

Video Training Sessions

The Purposeful Professional program includes access to a library of pre-recorded training videos that you can view at your convenience. You will have lifetime access to these materials, provided the program remains active and full payment of the program has been received by Stacey Barber. Should the program be discontinued, you will be notified in advance.

Payment

Full payment for The Purposeful Professional Program is due prior to the session's start unless otherwise agreed via a payment plan.

Cancellation of The Purposeful Professional

If you change your mind within 14 days of signing up for 'The Purposeful Professional' program and have not used any of the program's resources or services, a full refund will be offered.

Rescheduling of Hypnotherapy Sessions

If you need to reschedule a hypnotherapy session, you must notify Stacey Barber in writing at least 48 hours before the scheduled session. If you give less than 48 hours' notice, your session and payment will be forfeited.

Cancellation of Hypnotherapy sessions

If you need to cancel a hypnotherapy session, you must notify Stacey Barber in writing at least 48 hours before the scheduled session. If you do not give at least 48 hours' notice, your payment for that session will be non-refundable.

Confidentiality

Stacey Barber will maintain confidentiality with respect to all information disclosed or discussed during the hypnotherapy sessions, except as required by law.

Disclaimer

Hypnotherapy is not a substitute for medical or psychological treatment. Stacey Barber does not diagnose, treat, or cure any medical or psychological condition.

As part of the process, all clients are required to complete a questionnaire during their first session to disclose certain medical information before undergoing hypnotherapy.

While clinical hypnotherapy is generally safe, it is recommended that individuals who are epileptic or undergoing psychiatric treatment obtain a letter from their medical practitioner to confirm their suitability for hypnotherapy prior to signing up to the program.

Hypnotherapy outcomes may vary from client to client. It is important to note that no therapy can guarantee a 100% result.

PRIVACY POLICY/GDPR NOTICE

How will my data be stored?

In May 2018 the Data Protection Act was replaced by the General Data Protection Regulations (GDPR). The changes to the Data Protection Act are aimed at ensuring that your personal, confidential, and sometimes sensitive data, is held privately and securely.

How long will you hold my information for?

As a member of NCH (National Council for Hypnotherapy) I am required to keep written records stored securely for 8 years after the last interaction with an adult client and up to the age of 25 for a child under 16 when last seen or 26yrs for 17–18-year-olds.

What if I would like my data to be destroyed before this date?

Under GDPR rules, you can request the deletion of any of your records at any time.

Am I able to see or get a copy of the information held by you?

In line with GDPR, yes, to be received within 30 days.
