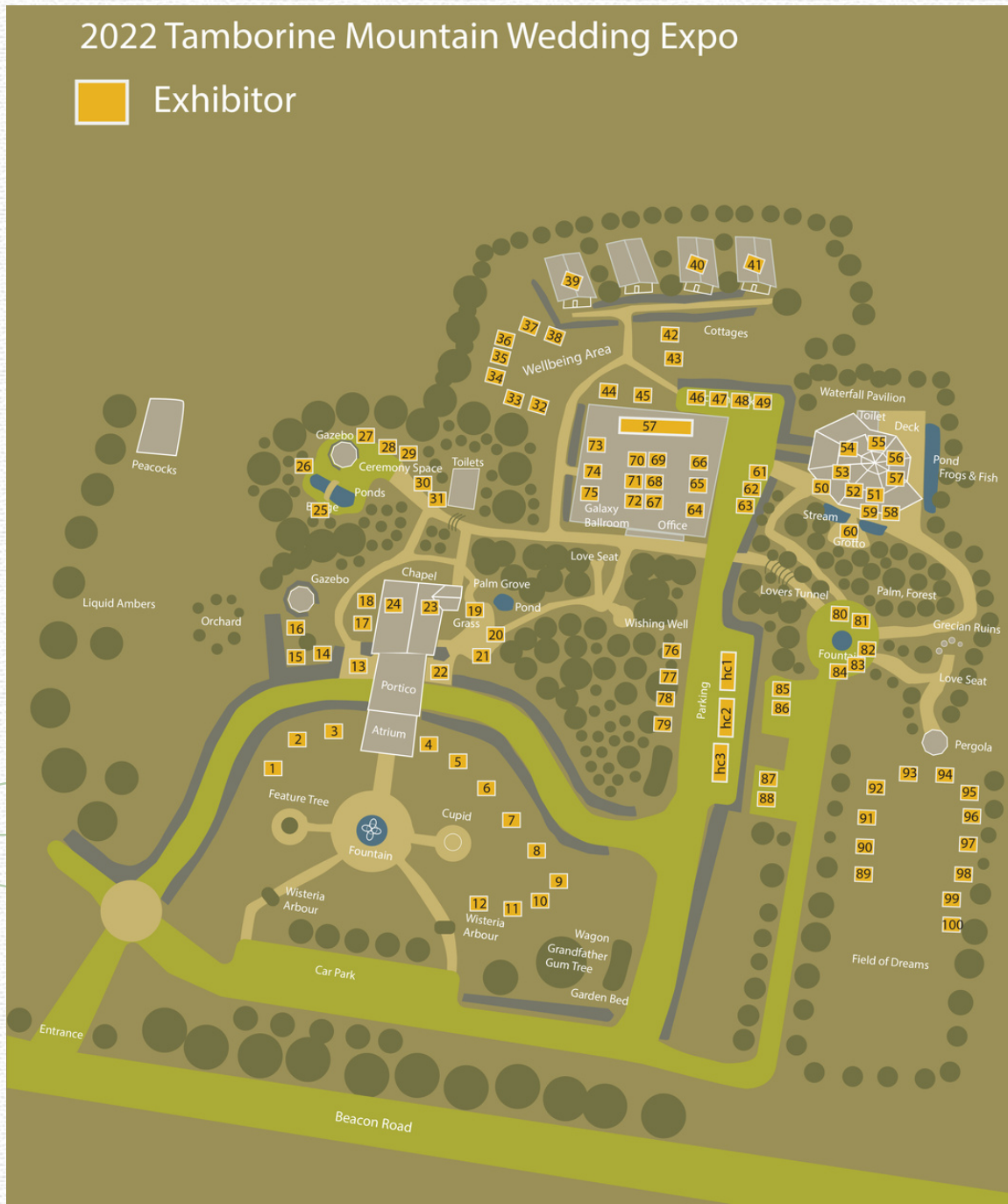

#### SET UP / BUMP IN

Access to Shambala Estate for set up will be varied for stall holders. You will be notified if your area is ready for bump in on Saturday night or from 7am - 9am on Sunday 14 August 2022. There will be no access prior to this date and time.

#### TRADING HOURS

Exhibitors will be required to operate between the hours of 10am - 3pm Sunday 14 August. All exhibitors must be ready to trade from 9:00am. All exhibitors must stay and be operational until the conclusion of the event.

No exhibitors are to dismantle stalls prior to 3pm. Access for vehicles for bump out will only be from 3:15pm.

#### EXHIBITOR INFORMATION

Stalls must be safely constructed and secured. We encourage all exhibitors to present their products and services in a professional manner. You will receive a style guide that must be adhered to as the look and feel of the event is more classic/boho with muted tones. You will be responsible for the look and feel of your exhibition space. Remember to bring everything that you will require.

All Wine & Beer providers will still be required to provide their liquor licenses to SRRC as well as Insurances such as Public & Product Liability.

#### EXHIBITOR STALLS

Exhibitors will be allocated a position at the discretion of the Shambala Estate. Exhibitors MUST use the stall site allocated to them on exhibition day and site locations ADDITIONAL DOCUMENTATION will not be amended on the day.

Shambala Estate reserves the right to enter a exhibitors allocated area and remove any article, sign, picture or printed matter, which in their opinion may be a cause of offence to the public.

Inclusions detailed for different stalls in application form. Please contact our event co-ordinators to discuss how they can help you get the most out of your expo space.

Significant promotion of your product prior, during & post event through our website, email marketing, social media and local papers.

#### PRODUCT/SERVICE OFFERING

Stallholders must not sell or promote any product or service, which has not been approved by the Tamborine Mountain Weddings Group and Shambala Estate.

#### SAFETY

The safety of our community is always at the forefront of our minds and we will continue to monitor the current Covid-19 restrictions and rules in all aspects of our planning. All events will need to comply with Covid Safe guidelines.

#### HOUSEKEEPING

All exhibitors are responsible for keeping their stall sites and surrounds tidy and clear of rubbish. You will need to leave the stall in the same condition that you found it - ensuring all items used to hang, or secure your visual displays are ENTIRELY removed.

NO thumb tacks are to be used on the VINYL walls of the event tents at any time. The use of sticky tape, double sided tape, blue tac, sticky dots, rope and fishing line is permitted as long as they ENTIRELY removed at the close of the expo.

The cost of any damage caused to exhibition sites due to non removal of exhibitors items will be charged to the exhibitor. Please note: Animals other than registered Assistance Dogs are not permitted at the event at any time.

#### ELECTRICITY

Electricity will be limited. If you require power, you will need to provide us with accurate details of how you will use power at your site and this MUST be emailed directly to [carol@tamborinegardens.com.au](mailto:carol@tamborinegardens.com.au). Failure to supply these details may result in not having access to electricity on the day. Appliances over 50 watts must be tagged and tested.

#### VEHICLES + PARKING

Parking will NOT be permitted within the event area. All vehicles must be parked in the designated exhibitor area after unloading on set up day. No vehicles will be allowed to remain onsite during the day of the Expo (other than vehicle vendors). There will be NO vehicle access during the event. Vehicles must follow the directions of Shambala Estate staff, marshals or security at all times.

#### INSURANCE + LICENCES

Shambala Estate and the Tamborine Mountain Weddings Group will not be under any responsibility or liability whatsoever for damages to stands or displays by loss, damage, theft, fire etc. All stallholders are required to have their own 'Public Liability (& Product Liability where applicable) Insurance' for an amount not less than \$10 000 000 for the duration of the setup, during the expo and pull down periods. Proof of which will need to be attached to the application form. Food and Beverage exhibitors must ensure they have the appropriate licences.

#### SECURITY

There will be no security on site. Security of the exhibitor's individual goods, including equipment etc is the sole responsibility of the trader. Shambala Estate and the Tamborine Mountain Wedding Group will not be held liable for the loss or damage of property.
