BACKGROUND:

2. Information About Us

2.1 Our Site is [owned and] operated by jeni raitsin [, a limited company registered in Isreal under company number 308657691, whose registered address is Ben Zvi st 16 Tel Aviv and whose main trading address is] **OR** [of] Ben Zvi st 16 Tel Aviv.

3. How Does Our Site Use Cookies?

3.1 Our Site may place and access certain first party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our [products] AND/OR [services]. We have

3.3.1 Strictly Necessary Cookies

3.3.2 Analytics Cookies
