### BUILDABLE PRICING FOR YOUR EVENT

***Bride's Makeup Package: \$240***

*Includes Trial and Day-of services. Full face makeup application with airbrush or conventional foundation.*

***Bride's Hair Design Package: \$240***

*Includes Trial and Day-of Services. Complete Bridal hair design (updo's, half up, all down, etc.)*

***\* Day-of Only Hair Design for Brides: \$150 | Day-of Only Makeup Application for Brides: \$150 \****

***Portraits / Engagement Session: \$200***

*Complete hair design, full face makeup application and application of individual lashes*

***Bridal Party Member's Makeup Application: \$90 ea.***

*Full face makeup application with airbrush or conventional foundation for wedding party attendants.*

***Bridal Party Member's Hair Design: \$90 ea.***

*Complete hair design (updo's, half up, all down, etc) for wedding party attendants.*

## *traveling minimums*

---

*There is a minimum requirement of four (bride + 3) receiving services for Bangs and Blush to travel on-location. It is an option to pay the difference to still be able to receive services at your location or schedule your day-of service at our beautiful studio location.*

## *the booking process*

---

*Use this checklist as your guide through the booking process!*

- *Visit [WeddingWire.com/bangsandblush](http://WeddingWire.com/bangsandblush) and "Contact this Vendor" to receive a Welcome Packet and discuss your wedding beauty needs.*
- *Receive initial proposal from Bangs and Blush via email.*
- *Review proposal and 'request a change' or 'accept' to move forward with booking.*
- *Secure hair and make-up team by signing your contract and submitting booking fee payment. Booking Fee: 20% booking retainer.*
- *Schedule hair and make-up trial run: 1 to 3 weeks prior to wedding day.*
- *Pay balance in full 10 days prior to event. Payment is non-refundable.*
- *Kick back, relax and let the pampering commence!*

## *side notes*

---

*Can I add on services after I have accepted my proposal and/or signed my contract? Yes! You can add services all the way up until the day-of. Services added on the day-of will be done AFTER we complete all services that have been paid for prior to.*

*What if I am an out-of-state bride? The entire booking process is done electronically. We are no stranger to destination weddings- if you are receiving a trial we will schedule it when you are in town whenever it is most convenient.*



## *what to expect + trial tips*

---

### WHAT IS A HAIR AND MAKE-UP TRIAL?

*Your hair and makeup trial is a time to come into our studio, meet your artistic team, and perfect the look you desire for your wedding day. This is a time to ask any questions you may have regarding day-of hair and makeup procedures as well as discuss timeline details.*

### HOW LONG DO HAIR AND MAKE-UP TRIALS TAKE?

*In our experience the hair and makeup trial time varies based on the individual Bride and her desired look. On average, we recommend that you schedule a minimum of 3 hours.*

### SCHEDULING YOUR TRIAL

*Trials are scheduled after we have received your booking payment. All trials are done at the Bangs and Blush Studio. It is recommended that you schedule your trial in the 1-3 weeks prior to your wedding (we do not schedule trials on Saturdays). **Side Note:** The day of your bridal portraits and/or final dress fitting are great days to schedule your trial.*

### PREPARING FOR YOUR TRIAL

- *Start looking for hair and makeup inspiration photos and bring them with you the day of your trial. When you are searching for ideas, look for photos that resemble you: face shape, eye shape, hair color, length & texture.*
  - *Wear white! Different colors and patterns can be distracting, wearing a white blouse will allow you to visualize your look as it would be seen on the day of!*
- *If you are wearing a veil or any hairpieces, we recommend you bring them so you can discuss placement with your hair stylist. Also, if you plan to wear earrings, a necklace, etc., consider bringing those items with you.*
- *If you have a timeline from your Photographer and/or Wedding Planner please bring us a copy or send via email prior to your trial date. This will allow us to determine our start time for the day of your wedding.*
- *Please arrive at your trial wearing no make-up and with clean, dry hair. (If you normally flat iron your hair, we recommend not to the day of your trial) If a prior engagement prevents you from arriving make-up free, you may cleanse your face at our studio prior to beginning your trial.*

### ALLERGIES

*If you are sensitive to any ingredients or products that you know of, please discuss this with your artists. The airbrush system we use and most of our artists' other products are marketed for all skin types.*
