PRIVACY AND COOKIE POLICY - ÖZGE

Özge Bold Global Styling Agency ("we", "us", "our" and "Özge") respects your privacy and is committed to taking reasonable steps towards protecting your privacy online and managing your information responsibly, in order to best understand the services that are most useful to you. The personal data will be processed in accordance with the laws of Turkey concerning internet privacy laws and international regulations such as the GDPR (applies since 25 May 2018), CCPA (applies since 1 January 2020) and all other international laws and regulations applicable to the jurisdiction of Özge.

For the purposes of the General Data Protection Regulation - GDPR (Regulation (EU) 2016/679, the "GDPR"), Özge Bold Global Styling Agency is the "data controller" (as defined in the GDPR) of the personal data, when it determines the purposes and means of the processing of personal data. Özge cares about your privacy and wants you to be familiar with how we collect, use and disclose data. This Privacy Statement covers the collection, use and disclosure on this Site where the statement is linked.

In addition, under the GDPR:

'Personal data' means any information relating to you and that identifies you, directly or indirectly;

'Processing' means any operation or set of operations which is performed on personal data or on sets of personal data.

Please note that any links to third party websites on Özge as partners are governed by their own privacy statements. Additionally, Özge contents may be subject to their own statements specific to the product or content and such statement will apply to the applicable privacy or content. Please read the following carefully as it explains our views and practices regarding your personal information, and how it is handled. By accessing or browsing our website, you confirm that you have read, understood and agree to this policy in its entirety.

If you do not agree with the practices described in this policy, you should not use our website. By providing us with your data, you warrant to us that you are of legal age to perform such activities on your own.

Types of Data We Collect. "Personal Data" means data that allows someone to identify or contact you, including, for example, your name, address, telephone number, e-mail address, as well as any other non-public information about you that is associated with or linked to any of the foregoing data. "Anonymous Data" means data that is not associated with or linked to your Personal Data; Anonymous Data does not, by itself, permit the identification of individual persons. We collect Personal Data and Anonymous Data, as described below.

(a) Information You Provide to Us.

• We may collect Personal Data from you, such as your first and last name, e-mail and mailing address, phone and password when you create an account to log in to our site.

- We retain information on your behalf, such as files and messages that you store using your Account.
- If you provide us feedback or contact us via e-mail, we will collect your name and e-mail address, as well as any other content included in the e-mail, in order to send you a reply.
- We also collect other types of Personal Data that you provide to us voluntarily, such as your operating system and version, product registration number, and other requested information if you contact us via e-mail regarding support for the Services.
- We may also collect Personal Data, such as at other points in the Services that state that Personal Data is being collected. (b)Information Collected via Technology.
- To make our Services more useful to you, our servers (which may be hosted by a third party service provider) collect information from you, including your browser type, operating system, Internet Protocol (IP) address (a number that is automatically assigned to your computer when you use the Internet, which may vary from session to session), domain name, and/or a date/time stamp for your visit.

Use of Your Personal Data

In general, Personal Data you submit to us is used either to respond to requests that you make, or to aid us in serving you better. We use your Personal Data in the following ways:

- identify you as a user in our system;
- provide improved administration of our Services;
- improve the quality of experience when you interact with our Services;
- send you a welcome e-mail to verify ownership of the e-mail address provided when your Account was created;
- send you administrative e-mail notifications, such as security or support and maintenance advisories;

Disclosure of Your Personal Data.

We disclose your Personal Data as described below and as described elsewhere in this Privacy Policy.

- (a)Third Party Service Providers. We may share your Personal Data with third party service providers, including, but not limited to, stylists, to: help schedule in-home beauty services, conduct online chat, provide you with the Services; to facilitate creation of accounts; to provide technical support; and/or to provide other services.
- (b)Affiliates and Acquisitions. We may share some or all of your Personal Data with our parent company, subsidiaries, joint ventures, or other companies under a common control ("Affiliates"), in which case we will require our Affiliates to honor this Privacy Policy. If another company acquires our company, business, or our assets, that company will possess the Personal Data collected by us and will assume the rights and obligations regarding your Personal Data as described in this Privacy Policy.
- (c) Other Disclosures. Regardless of any choices you make regarding your Personal Data (as described below), we may disclose Personal Data if we believe in good faith that such disclosure is necessary
- (a) in connection with any legal investigation;
- (b) to comply with relevant laws or to respond to subpoenas or warrants served on us;
- (c) to protect or defend our rights or property or that of other users of the Services; and/or
- (d) to investigate or assist in preventing any violation or potential violation of the law, this Privacy Policy, or Terms and Conditions.

Third Party Websites.

When you click on a link to any other website or location, you will leave our Site and go to another site and another entity may collect Personal Data or Anonymous Data from you. We have no control over, do not review, and cannot be responsible for, these outside websites or their content. Please be aware that the terms of this Privacy Policy do not apply to these outside websites or content, or to any collection of data after you click on links to such outside websites.

Your Choices Regarding Your Personal Data

- (a) Choices. We offer you choices regarding the collection, use, and sharing of your Personal Data.
- (a.i)We will periodically send you free newsletters and e-mails that directly promote the use of our Services. When you receive newsletters or promotional communications from us, you may indicate a preference to stop receiving further communications from us and you will have the opportunity to "opt-out" by following the unsubscribe instructions provided in the e-mail you receive or by contacting us directly (please see contact information below).
- (a.ii)Despite your indicated e-mail preferences, we may send you service related communication, including notices of any updates to our Terms of Use or Privacy Policy.
- (b)Changes to Personal Data. You may change any of your Personal Data in your Account by sending an e-mail to us at the e-mail address set forth below. You may request deletion of your Personal Data by us, but please note that we will keep all transactions as business records and may be required to keep other information and not delete it (or to keep other information for a certain time, in which case we will comply with your deletion request only after we have fulfilled

such requirements). When we delete any information, it will be deleted from the active database, but may remain in our archives. We may retain your information for fraud prevention or similar purposes.

Security of Your Personal Data.

We are committed to protecting the security of your Personal Data. We use a variety of industry-standard security technologies and procedures to help protect your Personal Data from unauthorized access, use, or disclosure. We also require you to enter a password to access your Account information. Please do not disclose your Account password to unauthorized people. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, while we use reasonable efforts to protect your Personal Data, we cannot guarantee its absolute security.

NOTICE FOR U.S. - CCPA

We are required by the California Consumer Privacy Act of 2018 ("CCPA") to provide to California residents an explanation of how we collect, use and share their Personal Information, and of the rights and choices, we offer to California residents concerning that Personal Information.

Personal information that we collect, use, and share. We do not sell personal information. As we explain in this Privacy Policy, we use cookies and other tracking tools to analyze website traffic.

Your California privacy rights. The CCPA grants California residents the following rights. However, these rights are not absolute, and in certain cases we may decline your request as permitted by law.
