I hereby agree to breed my mare:

to the stallion, **Cats Picasso** in the year 2025, at the Stallion Fee of **\$1600+GST payable to Plough Equine Veterinary Services** (Stallion Manager), there is also a **\$400+ GST booking fee per year.**

All mare care/board, veterinary evaluations, palpations, ultrasounds, follow-ups etc are the responsibility of the mare owner.

1. There will be a **\$400+gst non-refundable booking fee** payable to Stallion Manager. Booking Fee is NOT REFUNDABLE (exception: see bullet 5) and the balance of **\$1600+GST MUST BE PAID IN FULL prior to breeding via E-Transfer or cheque.** For semen being purchased and shipped to the USA there is no GST.

2. Cooled shipped semen, Frozen semen and artificial insemination (AI) available. **Contact Plough Equine Reproduction Services at 604-835-7736 for current rates and collection schedules for shipped semen, AI costs and mare care costs/options.**

NO live coverage.

3. You agree to breed my mare up to and including July 15, unless otherwise arranged at the time of signing of this contract.

4. It is further agreed that should **Cats Picasso** die or become unfit to breed, then this contract shall become null and void, and any money paid as part of the Stallion Fee shall be refunded to me (veterinary fees, etc. are NOT REFUNDABLE).

5. It is my understanding that Stallion Owner, or its manager or any employee or family member of Manager or Owner will not be responsible for accident, sickness or death to mare or foal in any part of the breeding process. **In the event of any injury or death to my animal, I will look solely to my own insurance and in the event, that anyone shall assess a cause of action against you on account of any injury or death to my horse, then in such event I agree to hold you harmless from any such cause of action including the cost of defending same.**

6. It is mare owner's responsibility to ensure cross of stallion and mare is genetically acceptable and any genetic abnormalities are solely the mare owners' responsibility.

Cats Picasso has been 5 panel tested HERDA N/H, 4 panel N/N.

7. Stallion Owner has the right to refuse to breed any mare for any reason.

8. Live foal guarantee:

a. It is agreed that you guarantee a live foal to owner of the above-named mare at the time of signing this contract and if my foal does not stand and suck, I will be entitled to a free breeding the following year to the same mare (unless mutually agreed). **This live foal guarantee only applies if I notify stallion owner within one (1) week from death; this notice must be accompanied by a statement from a licensed Veterinarian.** There shall be no liability upon you on account of said guarantee except to

grant to me a free breeding for 1 mare the following year. Said free breeding shall refer to the breeding fees only. There will be a charge of \$400+gst chute fee and further collection fees.

- b. If the mare proves not to be in foal in the year bred, or loses her foal, as stated in (a) above, the stallion owner has the option to rebreed the same mare **the following year**. If mare is not rebred the following year or the mare owner fails to deliver her for breeding **the following year**, then this contract becomes null and void. It is the responsibility of the mare owner to prove mare is or is not in foal.
- c. Live foal guarantee becomes null and void if mare is returned to training after pronounced in foal.

9. Copy of mares' registration papers showing owner at time of breeding must accompany signed breeding contract.

10. I agree not to assign or transfer this contract without your prior consent.

11. NO MARE WILL BE BRED UNTIL MARE BREEDING CONTRACT IS SIGNED AND A COPY OF REGISTRATION PAPERS WITH CURRENT OWNERS NAMED IS RECEIVED. PAYMENT OF NON-REFUNDABLE STALLION FEE MUST BE RECEIVED IN FULL.
