

FAQ sheet

Q: Is Foster Arizona Housing Project a Qualifying Charitable Organizations (QCO)?

A: Yes, Foster Arizona Housing Project is a Qualifying Charitable Organizations. Our QCO Code is 22092.

Q: How can I donate?

A: You can donate online at: <https://fosterarizonahousingproject.org/donate#/> or by check, making it payable to Foster Arizona Housing Project and sending it to: PO Box 20787 Mesa, AZ 85277

Q: How do I get the Arizona Tax Credit?

A: You must complete the Arizona Tax form 321 online at: <https://azdor.gov/forms/tax-credits-forms/credit-contributions-qualifying-charitable-organizations> and submit with your Arizona Tax Return. Note: Make sure you download the matching form for the proper year.

Q: What is the maximum credit for any tax year?

A: Taxpayers filing as “single” and “head of household” status may claim a maximum credit of \$618. Taxpayers that file as “married filing joint” may claim a maximum credit of \$1,234. Taxpayers filing as “married filing separate” may claim a maximum credit of \$618

Q: What is the deadline?

A: Credit eligible contributions must be made on or before the 15th day of the fourth month following the close of the taxable year may be applied to either the current or the preceding taxable year and are considered to have been made on the last day of that taxable year.

Q: Is Foster Arizona Housing Project a Qualifying Foster Care Charitable Organization (QFCO)?

A: No, contributions to Foster Arizona Housing Project currently do not qualify for the Qualifying Foster Care Charitable Organization while the Foster Care Charitable tax credit aims to support kids in foster care, FAHP focuses on supporting those transitioning out of foster care.

Q: How does this tax credit work?

A: The state of Arizona offers taxpayers the opportunity to make contributions to schools, non-profit organizations that reduce the amount of tax owed to the state or increase the amount of the taxpayer's refund, dollar-for-dollar. There are three main communities tax credit donations serve, and donors can contribute to any or all of them, QCO's & QCFO's, Public & Private Schools, and Military Family Relief.
