### Booth Requirements/Merchandising

**All spaces must be styled and merchandised to present an attractive and creative display. No flea-market style set-ups, no uncovered table-top displays, all tabletops must be covered with fabric or cloths that come to the floor. The covering you choose must represent a professional display.** Tablecloths are available for rent through the Humboldt Chamber at vendor expense.

### Booth Space Rental- Please read carefully

This is an Indoor and Outdoor event. There are limited spaces in the outdoor courtyard, and these spaces will require you to provide your own **WHITE** tent. Electricity is not available in the outdoor area. This year there are a few spaces that we will be offering that are only sized for an 8ft table. There are only two of these spaces available. Vendor will be responsible for providing their own table for this space.
