Local Lynchings - Annotated Timeline - J. B. Hogan

1840 – Caroline, an enslaved woman – Mrs. Crawford death

"...was examined and blood was found upon her clothes...the men of the community held a court [Sheriff absent], appointed a judge and jury [she made a full confession] and condemned the slave woman to hang." *Flashback*, Feb. 1982, p. 15 and *Goodspeed*, 1889, pp. 159-160.

1849 - Alph, an enslaved man [Benton County] - James Anderson death

"...reportedly killed James Anderson...whites of Fayetteville were determined to exact revenge immediately...A posse...shot him twice...finally captured...admitted to murder [not clear if offered freely or coerced and implicated a white man in the crowd who "instigated him"]...was hanged without trial on October 20 [1849]. Bullets and Fire, pp. 27-28.

1853 – Aldred, an enslaved man – his mother's death

[reported in New York Times, March 15, 1854] "...convicted for the killing of his mother. He was promptly hanged." Flashback, Feb. 1982, p. 16.

1856 - Anthony, Aaron, and Randall, enslaved men - James Monroe Boone death

Anthony and Aaron accused of Boone's death, released of charges and freed by circuit court, June 30-July 7, 1856. Hung by mob, July 7, 1856. Randall received guilty verdict but denied appeal and hung by the State, August 1, 1856. *Flashback*, Feb. 1982, p. 16.

1859 - Bob and two unnamed enslaved men - runaway gun battle

Bob was formerly "property of Dr. Deane," shootout on road to Mt. Comfort, Bob killed by "arresting crowd," one other man shot in eye, the third shot in the back (neither wound mortal). *Flashback*, Feb. 1975, p. 39.

1860 - Unnamed enslaved man - Jacob Mullis death

"admitted to killing Mullis insisting it was self-defense...went willingly to the Fayetteville jail without a struggle...an angry crowd [from Mountain Township, Hogeye area, southeast of Prairie Grove]...took matters into their own hands...took him from the jail and hung him to a limb." *Bullets and Fire*, p. 22

Of note:

1849 – John Smith (free man) – accused of murder (unknown victim) – acquitted – Wash. Co. Murders, p. 1 1860 – Horace (enslaved man) – accused of murder (unknown victim) – implied death penalty – *Judge and Jury*, p. 17

No known lynchings in Fayetteville after 1860
