#### SPILL MANAGEMENT

Land Spill: Stop leak if you can do it without risk. Recover by pumping or with suitable absorbent.

**Water Spill:** Stop leak if you can do it without risk. Confine the spill immediately with booms. Warn other shipping. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

#### HANDLING

Prevent small spills and leakage to avoid slip hazard. Material can accumulate static charges, which may cause an electrical spark (ignition source).
