## SELLER AGREEMENTS

1. THIS PUPPY/DOG IS A PUREBRED MINIATURE LONGHAIR DACHSHUND. THIS PUPPY/DOG IS OF TYPICAL TEMPERAMENT AND STRUCTURE AND EMBODIES THE BASIC STANDARDS OF THE BREED.
2. THE PEDIGREE FURNISHED IS CORRECT.
3. THE PUPPY/DOG IS: REGISTERED( ) REGISTERABLE ( X ) WITH THE AKC.
4. THE REGISTERED NAME IS/WILL BE \_\_\_\_\_; OR
5. THE KENNEL PREFIX **BLUE BOW** MUST BE USED AS THE FIRST WORD OF THE REGISTERED NAME OR BE USED IN THE NAME.
6. AKC REGISTRATION PAPERS AND INSTRUCTIONS WILL BE PROVIDED TO THE BUYER ONCE THE SALE IS COMPLETE, AND IT IS THE BUYER'S RESPONSIBILITY TO FILL THEM OUT AND RETURN TO THE AKC ALONG WITH THE REGISTRATION FEE. THIS PROCESS CAN ALSO BE COMPLETED ONLINE IF PREFERRED.
7. THE REGISTRATION IS LIMITED. PUPPIES SOLD ON LIMITED REGISTRATION MAY NOT BE SHOWN IN AKC CONFORMATION SHOWS OR BRED. THE BUYER'S UNDERSTANDING AND ACCEPTANCE OF THIS CONDITION ARE SIGNIFIED HERE BY HIS/HER INITIALS: \_\_\_\_\_ ON \_\_\_\_\_(DATE).
8. THE PURCHASE PRICE OF THIS PUPPY/DOG WILL BE REFUNDED IF THE BUYER FURNISHES THE SELLER WITH A VETERINARY CERTIFICATE INDICATING THAT THE PUPPY/DOG IS UNWELL OR UNSOUND AND RETURNED WITHIN 72 HOURS AFTER PICK UP. THE SELLER WILL REIMBURSE NO VETERINARY OR SHIPPING COSTS.
9. THE PUPPY/DOG IS HEALTHY AT THE TIME OF SALE AND HAS HAD IMMUNIZATIONS ENUMERATED IN THE ATTACHED HEALTH RECORD ALONG WITH ANY/ALL VETERINARY NOTES.
10. IF AT ANY TIME THE BUYER IS UNABLE TO KEEP OR CARE FOR THE PUPPY/DOG, IT MUST BE RETURNED TO THE SELLER. THE PUPPY/DOG MAY NOT BE TRANSFERRED OR SOLD BY THE BUYER. THE BUYER'S UNDERSTANDING AND ACCEPTANCE OF THIS CONDITION IS SIGNIFIED HERE BY HIS OR HER INITIALS: \_\_\_\_\_ ON \_\_\_\_\_(DATE). THE SELLER WILL ENDEAVOR TO PLACE ANY RETURNED PUPPY/DOG AS ADVANTAGEOUSLY AS POSSIBLE. IF A PURCHASE PRICE IS OBTAINED FOR THE PUPPY/DOG, IT WILL BE REFUNDED TO THE ORIGINAL BUYER, LESS ANY COSTS OF PLACEMENT. BUYER UNDERSTANDS THAT THEY MAY NOT RECEIVE THE FULL AMOUNT BACK. IF THE PUPPY/DOG IS PLACED FREE OF CHARGE, NO MONEY WILL BE RETURNED TO THE ORIGINAL BUYER. NO VETERINARY OR OTHER COSTS OF KEEPING THE PUPPY/DOG, OR ANY OTHER COSTS INCURRED BY THE BUYER RESULTING FROM HIS/HER OWNERSHIP OF THE PUPPY/DOG, WILL BE PAID BY THE SELLER TO THE ORIGINAL BUYER OF THE PUPPY/DOG UNDER ANY CIRCUMSTANCES.
11. THE SELLER IN NO WAY GUARANTEES ANY FUTURE PHYSICAL ATTRIBUTES SUCH AS COAT COLOR OR ADULT SIZE/WEIGHT NOR THAT THIS PUPPY/DOG WILL BE OF A CERTAIN DEMEANOR.
12. THE SELLER OFFERS A ONE YEAR HEALTH GUARANTEE AGAINST LIFE-THREATENING CONGENITAL DEFECTS. THIS GUARANTEE WILL PROVIDE THE BUYER WITH A REPLACEMENT PUPPY OF THE SAME GENDER AND OF EQUAL VALUE FROM THE NEXT AVAILABLE LITTER, IN THE EVENT OF THE DEATH OF A PUPPY. SHOULD A PUPPY DIE WITHIN THE GUARANTEED PERIOD, A NOTARIZED AUTOPSY REPORT FROM A LICENSED VETERINARIAN WILL BE REQUIRED. THIS REPORT MUST ATTRIBUTE THE CAUSE OF DEATH TO A CONGENITAL DEFECT. BLUE BOW KENNELS' VETERINARIAN MUST AGREE WITH THIS REPORT.

NO OTHER WARRANTIES OR GUARANTEES, EXPRESSED OR IMPLIED, ARE MADE UNDER THIS CONTRACT EXCEPT AS STATED ABOVE.

## BUYER AGREEMENTS

THE BUYER AGREES THAT IF AT ANY TIME, AND FOR ANY REASON, HE/SHE IS UNABLE TO KEEP OR PROPERLY CARE FOR THE PUPPY/DOG, IT SHALL BE RETURNED TO THE SELLER AND NO ONE ELSE. THE BUYER'S UNDERSTANDING AND ACCEPTANCE OF THIS CONDITION IS SIGNIFIED HERE BY HIS/HER INITIALS: \_\_\_\_\_ ON \_\_\_\_\_(DATE).

1. THE BUYER AGREES THAT A PUPPY/DOG IS A LIFELONG COMMITMENT AND AGREES TO PROVIDE A COMFORTABLE AND SAFE ENVIRONMENT FOR THEIR PET AT ALL TIMES.
2. THE BUYER AGREES TO MAINTAIN THE PUPPY/DOG'S HEALTH WITH YEARLY CHECKUPS AND VACCINATIONS AS SPECIFIED BY THEIR VETERINARIAN AND TO KEEP THE PET PARASITE FREE.
3. THE BUYER AGREES TO PROVIDE PROMPT MEDICAL CARE WHEN NECESSARY AND SHOULD THE PUPPY/DOG BECOME ILL OR UNSOUND, ANY AND ALL COSTS OF TREATMENT WILL BE THE RESPONSIBILITY OF THE BUYER.
4. THE BUYER AGREES TO PROVIDE PROPER GROOMING.
5. THE BUYER AGREES TO PROVIDE PROFESSIONAL QUALITY FOOD TO ENSURE PROPER NUTRITION. BUYER WILL ALSO MAKE SURE THAT FRESHWATER IS AVAILABLE AT ALL TIMES. THE BUYER WILL ALSO KEEP THE PUPPY/DOG IN AN APPROPRIATE LEAN WEIGHT TO MAXIMIZE THE PUPPY/DOG'S SOUNDNESS AND LONGEVITY.
6. THE BUYER AGREES THAT THIS PET WILL NOT BE USED FOR BREEDING AND AGREES TO HAVE IT SPAYED/NEUTERED AT THE AGE RECOMMENDED BY THEIR VETERINARIAN (THIS IS USUALLY BETWEEN 6 MONTHS TO 1 YEAR OF AGE).
7. THE BUYER UNDERSTANDS THAT THERE IS AN INCREASED RISK OF INTERVERTEBRAL DISK DISEASE(IVDD) IN ALL PUREBRED DACHSHUNDS AND THAT IF A PUPPY/DOG DEVELOPS THE DISEASE IT IS EXCLUDED FROM ANY HEALTH GUARANTEE MADE BY THE SELLER.
8. THE BUYER UNDERSTANDS THAT COLOR DILUTION ALOPECIA OR CDA IS A DISEASE THAT CAN AFFECT THE COAT QUALITY OF DOGS OF DILUTED COLORS SUCH AS "BLUE" OR "ISABELLA". WHILE NONE OF BLUE BOW KENNELS' DOGS HAVE CDA THERE IS CURRENTLY NO GENETIC TESTING FOR THE DISEASE AND THEREFORE WE CAN NOT GUARANTEE THAT OUR PUPPIES WILL NOT DEVELOP IT AT SOME POINT.
9. THE BUYER AGREES NOT TO SUE THE SELLER AND TO PAY ANY AND ALL COURT OR ATTORNEY FEES INCURRED BY THE SELLER SHOULD ANY SUIT BE BROUGHT AGAINST THE SELLER REGARDING THIS PUPPY/DOG BY ANY PERSON. THE BUYER SIGNIFIES ACCEPTANCE OF THIS CONDITION BY INITIALING HERE: \_\_\_\_\_ ON \_\_\_\_\_(DATE)
