# PROHIBITED & RESTRICTED ITEMS

## For U.S. Origin Shipments

### PROHIBITED COMMODITIES

#### NOT ACCEPTABLE FOR TRANSPORT

The following commodities are NOT acceptable for transport UNDER ANY CIRCUMSTANCES including domestic (USA) moves.

- Live animals, reptiles, snakes, birds, insects (other than those listed below for domestic transit under restricted commodities)
- Bullion
- Currency
- Firearms (Parts thereof including paintball, pellet guns, air rifles, etc.) (Except for Domestic exceptions listed below under restricted commodities)
- Pornography
- Drugs / Narcotics (illegal)
- Human remains (including ashes)
- Counterfeit or Pirated goods or material

Any item(s), the carriage of which is prohibited by any law, regulation or statute of any federal, state or local government to or through which the shipment may be carried.

### SPECIAL CARE

#### MAY BE ACCEPTABLE FOR TRANSPORT

The following commodities MAY be acceptable for transport without restriction unless otherwise noted, if the following conditions are accepted by the shipper:

#### Artwork, Antiques and Collectables

- Independent proof of value (replacement) must be available upon request
- Shipments must be professionally packaged
- Shipments in excess of USD 10,000 must be approved and assessed for risk for authorization before items of this value can be shipped (please contact us for more details).

#### Medical Samples

- (eg. biological/diagnostic specimens, blood, urine, bodily fluids, etc.)
- May only be carried if NOT classified as infectious or dangerous goods
- Items must be packed and labeled according to proper regulations
- Shipments must be sent through Express Air Service
- eGlobalUSA is not liable for spoilage or dehydration of goods due to delays

#### Perishable Items:

- (eg. flowers, plants, foodstuffs, items requiring temperature control, etc.)
- eGlobalUSA does not provide temperature controls, therefore, items must be packaged appropriately for transit.
  - Domestic (USA) shipments must only ship through overnight air and must be packed appropriately for up to 48 hours. Friday and Saturday shipments must be packed for up to 72 hours.
  - International shipments must be packaged appropriately for 24 hours greater than estimated transit time
- Perishable shipments sent outside the U.S. must not exceed USD 500
- Shipments must be sent through Express Air Service
- eGlobalUSA is not liable for spoilage or degradation of goods due to delays

### RESTRICTED COMMODITIES

#### MAYBE ACCEPTABLE FOR TRANSPORT

The following commodities MAY be acceptable for transport by eGlobalUSA with pre-approval, if certain conditions or circumstances are fulfilled. Please contact eGlobalUSA for more information. Additional fees may apply.

#### Alcoholic Beverages

(eg. beer, wine, spirits)  
Domestic (USA) wine carriage only from licensed distributors. Adult signature required. Outside the U.S. may be acceptable to send wine, beer and spirits from licensed distributors.

#### Live Animals

(Limited to non-venomous, frogs, insects, lizards, tortoises, sea life, and worms) Domestic (USA) transportation only under certain conditions. Not permitted to be sent outside the U.S. eGlobalUSA is not liable for degradation of goods due to delays. Shipments must be sent through Express Air Service.

#### Dangerous Goods

(Hazardous or combustible materials, including asbestos and ammunition, as defined by 49CFR, ICAO/IATA or by applicable sea or road transport regulations) Domestic (USA), including Puerto Rico, and Canada transportation only under certain conditions. Not permitted to be sent outside the U.S. or Canada with the exception of dry ice, diagnostic specimens (UN3373) and EQ's (Excepted Quantities) to certain predefined sectors.

#### Firearms

(Parts thereof including paintball, pellet guns, air rifles, etc.) Domestic (USA) transportation only from and to licensed dealers. Domestic firearms must be rendered mechanically not fireable. NOT PERMITTED TO BE SENT OUTSIDE THE U.S.

#### Industrial Diamonds / Carbons

For values over USD 10,000.

#### Jewelry

Over individual unit values of USD 100 (finished jewelry including watches)

#### Negotiable Instruments

(Currency and Bullion is prohibited) Domestic (USA) exceptions for certain other negotiable instruments. eGlobalUSA has no liability for negotiable value. Negotiable instruments in bearer form not permitted to be sent outside the U.S.

#### Precious Metals and Stones

(Including unfinished jewelry)

#### Tobacco Products

Domestic (USA) restricted (shipments of cigarettes to individual consumers is prohibited). Adult signature required. Outside the U.S. many countries have specific import restrictions. Please contact Customer Service.
