

2. BINARY COMMISSION BONUS

Each purchase by a Brand Partner is given a point value which is categorized as that Brand Partners Personal Volume or PV. The PV associated with each Brand Partner purchase flows UPLINE through the network as Business Volume or BV.

Active = Pack +55 PV pts / 1 Sleeve per month autoship
Qualified = Enroll 1 Person on Left & Enroll 1 Person on Right



To Be Binary Qualified:

1. Must have an Active Valid Status - 110 Rolling PV (31 Days)
2. Must have purchased an Advanced pack OR Lifetime PV of 300
3. Must have two personally sponsored active Brand Partners* in your left leg 4.
4. Must have two personally sponsored active Brand Partners* in your right leg

*55 PV in rolling 31-days

PV = Personal Volume | BV = Business Volume | BP = Brand Partner

DISTRIBUTOR RANK QUALIFICATIONS:

MANAGER

- Be an Advanced Pack Brand Partner or above
- Generate a minimum of 110 PV per Month
- Have 2 personally sponsored Active Core Packs or higher

DIRECTOR

- Be an Advanced Pack Brand Partner or above
- Generate a minimum of 110 PV per month
- Have a total of 3 personally sponsored Active Core Packs or higher
- Have 1 personally sponsored Brand Partner who achieves Manager status on each leg

SENIOR DIRECTOR

- Must be Director status qualified
- Have 2 personally sponsored Brand Partner who achieves Director status
- Earn 10,000 BV through line of sponsorship in 30 day period

EXECUTIVE DIRECTOR

- Must be Senior Director status qualified
- Earn 50,000 BV through line of sponsorship in 30 day period

PRESIDENTIAL DIRECTOR

- Must be Senior Director status qualified
- Earn 100,000 BV throughline of sponsorship in 30 day period

SENIOR PRESIDENTIAL DIRECTOR

- Must be Senior Director status qualified

5. SENIOR LEADERSHIP GLOBAL POOL - BONUS SHARES (PAID QUARTERLY)

ELIGIBILITY REQUIREMENTS

- Paid-As SPD
- Based on your performance in the prior quarter
- 32 week GU 600K

G U GROWTH SHARES = 1 SHARE

- Baseline G U Average calculated from 13 weeks prior to Q4
- For every 20K in G U growth over the baseline

QUALIFYING LEG SHARE = 5 SHARES

- Each leg (excluding the largest) producing over 100K G U
