

## **OFFICIAL RULES – Manifestation Babe Cash Flow Training Giveaway**

1. **HOW TO ENTER:** No purchase or payment of any kind is necessary to enter or win this MB Free 3-Day Challenge (the **!Promotion**). Any purchase or payment will not increase your chance of winning the Promotion. The Promotion begins at 10:00am PST on May 15th, 2024 and ends at 11:59pm PST on May 17th, 2024. (the **!Promotion Period**). Throughout the Promotion Period, you may enter the Promotion by following the Instagram account @manifestationbabe (the **Account**) and following the instructions in the description of each video including but not limited to posting a dedicated, static in-feed post on your Instagram account featuring or in response to each assignment from the Live (each a **Post**). Each Post must utilize the secret hashtag from the Live as well as #MBPromotion in the caption above the fold (e.g. above the “see more”). Except as provided above, there is no minimum length or format required for each Post (e.g. Post can be a static image (that you own or have the rights to) with the answer to the assignment included in the caption, or a video of you reading your answer to the assignment).
