Registered Nurse Obstetrics Per Diem - Nights	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. license. BLS and successful completion of neonatal resuscitation within six months of employment.</p> <p>Position Responsibilities: The staff nurse in Obstetrics functions independently in performing the nursing process through assessment, planning, implementation and evaluation of safe therapeutic care for all patients during labor, deliver, immediate post-partum and newborn care; including those patients in complex situations with overt and covert needs and/or complications of treatment during his/her shift. Registered Nurse Intensive Care Unit Full Time/Per Diem	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. License. BLS and ACLS certification required within six (6) months. Minimum of one (1) year critical care experience within the last three (3) years required. Satisfactory completion of a course in critical care, intensive care or coronary care within the last three (3) years preferred.</p> <p>Position Responsibilities: Function independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment on his/her shift. The staff nurse manages and coordinates the clinical activities on the patient unit during his/her shift.</p>
Registered Nurse Med/Surg Full Time Night Shift	<p>Required Education, Licenses/Certifications, and Experience: Current California RN License and BLS required. Minimum of one (1) year acute care experience within the past three (3) years preferred.</p> <p>Position Responsibilities: The staff nurse in the Med/Surg Unit functions independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment on his/her shift. The staff nurse manages and coordinates the clinical activities on their patient assignment and may be assigned to coordinate the unit activities during his/her shift.</p>
CMA F.M. Clinic Full Time	<p>Required Education, Licenses/Certifications, and Experience: Current Medical Assistant certification required. BLS required within three (3) months of hire. Six (6) months experience in patient care in a clinical/medical office preferred.</p> <p>Position Responsibilities: A medical assistant is a member of the nursing team who functions under the direction, guidance, and supervision of an RN/LVN and/or licensed physician/mid level provider. A medical assistant, with guidance, assists in planning, providing, and evaluating nursing care for patients and in coordination nursing care activities with other health care disciplines.</p>
Medical Lab Technologist - CLS Laboratory Full Time	<p>Required Education, Licenses/Certifications, and Experience: Current California Department of Health Services Clinical Laboratory Scientist License required. One (1) to three (3) years' experience preferred.</p> <p>Position Responsibilities: Performs all Laboratory test necessary for the diagnosis and treatment of patients at the request of the attending physician(s). Responsible for reporting accurate results substantiated by the use of appropriate controls. Demonstrates proficiency and understanding of routine procedures for all areas of the clinical laboratory with minimal supervision.</p>
Speech/Language Pathologist Rehabilitation Services Full Time	<p>Required Education, Licenses/Certifications, and Experience: Licensed or License eligible as a Speech/Language Pathologist in the State of California. Successful completion of CFY under the supervision of a Speech/Language Pathologist.</p> <p>Position Responsibilities: Responsible for organizing, conducting, and developing a medically prescribed program of speech therapy within both hospital and outpatient settings.</p>
Registered Nurse Emergency Department Full Time - Nights	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. License. BLS and ACLS certification required within three (3) months. PALS, TNCC, MICN preferred. Minimum of one (1) year acute care experience within the last two (2) years preferred. Six (6) months recent experience in Emergency department desirable.</p> <p>Position Responsibilities: The staff nurse in the Emergency Department functions independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment in the Emergency Department. Manages and coordinates the clinical activities in the department during his/her shift.</p>
Registration Clerk/Aide Emergency Department Per Diem	<p>Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalency required. BLS required within three (3) months of hire/transfer. Ability to write legibly, spell correctly and perform basic mathematics required. Knowledge of medical terminology preferred. Must have computer/typing skills, interpersonal and communication skills, and able to physically assist with the care of the patients.</p> <p>Position Responsibilities: The Emergency Department Clerk/Aide will perform various clerical duties and</p>

	non-professional services necessary in caring for the personal needs and comfort of the patients.
Admit/PBX Clerk Business Office Per Diem	Required Education, Licenses/Certifications, and Experience: High school diploma or GED equivalent required. Previous clerical experience, basic computer entry experience required. Knowledge of medical terminology and various filing techniques required. Position Responsibilities: Operate switchboard terminal in conjunction with telephone and paging systems. Interview patients or patients' representatives. Computer data entry of patient and billing requirements.
Family Nurse Practitioner FM Clinic Full Time	Required Education, Licenses/Certifications, and Experience: Master's Degree, and California Family Nurse Practitioner license required. BLS required. Position Responsibilities: In collaboration with a Physician, perform assessments and diagnosis, initiate treatment and /or therapy. Take patient history and perform physical examinations.
Physician Assistant Emergency Department Full Time	Required Education, Licenses/Certifications, and Experience: Bachelor's degree and California Physician Assistant license required. BLS, ACLS, PALS required. ATLS (once, within six months) required. Position Responsibilities: In collaboration with a Physician, perform assessments and diagnosis, initiate treatment and /or therapy. Take patient history and perform physical examinations.
Registered Pharmacist Pharmacy Full Time	Required Education, Licenses/Certifications, and Experience: Current California Pharmacy license required. Position Responsibilities: Compounds and dispenses medications by means of standard physical and chemical procedures to fill written medication prescription requests issued by qualified prescribers.
LVN FM Clinic Full Time	Required Education, Licenses/Certifications, and Experience: Current California LVN license required. BLS required within three (3) months of hire. Two (2) years of nursing experience in a doctor's office preferred. Position Responsibilities: Administers nursing care to designated patients under the supervision of an FNP, PA, or Physician.
Surgical Tech Surgery Services Part Time, Benefited	Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalent required. Scrub Tech certification preferred. BLS required within three (3) months. Position Responsibilities: Under the direct supervision of the RN, does a variety of duties in the operating room to assist the surgery team; functions as a member of the sterile team creating and maintaining a sterile field and issuing instruments to surgeons.
Cashier Patient Accounting Full Time	Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalent required. Previous experience in health related field preferred. Knowledge of insurance, MediCare, Medi-Cal and basic accounting needed to reconcile remittance advance and bank deposits. Position Responsibilities: Responsible for accounting of all receipts made by the hospital.
