**IMPORTANT PAYMENT NOTES and ADVISORIES:**

- Dancers performing in Spring Concert **MUST** turn in **ALL FORMS AND FEES AT ONE TIME, TOGETHER**, or pay the **CHANGE FEE** of \$15 if forms, fees, and / or performance commitment forms or fees are submitted separately.
- Fees Due at Winter / Spring Registration, no later than Thursday, January 16: Tuition #1 of 3, Spring Concert Production Fee, Annual Registration, if not registered Fall 2024, and a \$100 BPPCEP separate \$100 deposit check for Parent (5) hours, with matching forms.
- Forms Due with fees no later than Thurs., Jan. 16: Schedule, Performance Agreement, Billing Page, Dancer Reg., if new.
- Registration opened in December. Spaces are taken once fees and forms are submitted. Incomplete registrations do **NOT** guarantee spaces in classes or the cast. Casting builds as each complete registration packet is received.
- Tuition #2 of 3 is due no later than 2/15 AND Tuition #3 of 3 is due no later than 4/15. The **LATE FEE** is \$15.00.
- To perform in our May 24 Spring Concert, dancers must be fully registered no later than Thursday, January 16 due to costume ordering restrictions. There is **NO LATE REG.** for Spring Concert due to tight costume ordering deadlines
