The 765 engine is performing pre-season work including safety valve setting, inspections and steam-up. Rick reported that they will also be obtaining much information and photos regarding their electrical and braking systems.

Since they were away a project list has been put together for you and posted in the WHQ.

Rick also wanted to give you an update regarding the crossheads, safety valves and brake shoes.

Sam L. Informs us that one crosshead assembly is complete and the other is well on its way. He anticipates both should be finished by the end of the month.

Bob K. is overseeing the safety valve repair work there in California. Century Spring Co. is fabricating new springs which will then be delivered to Basin Valve Co. for final valve reconditioning and setting of the pressures.

We need to concentrate work on finishing sleeve grinding. We need to get all the wasted ones removed so we can bring in the Henderson welders to finish the work. All replacement sleeves need to be prepped for welding.
