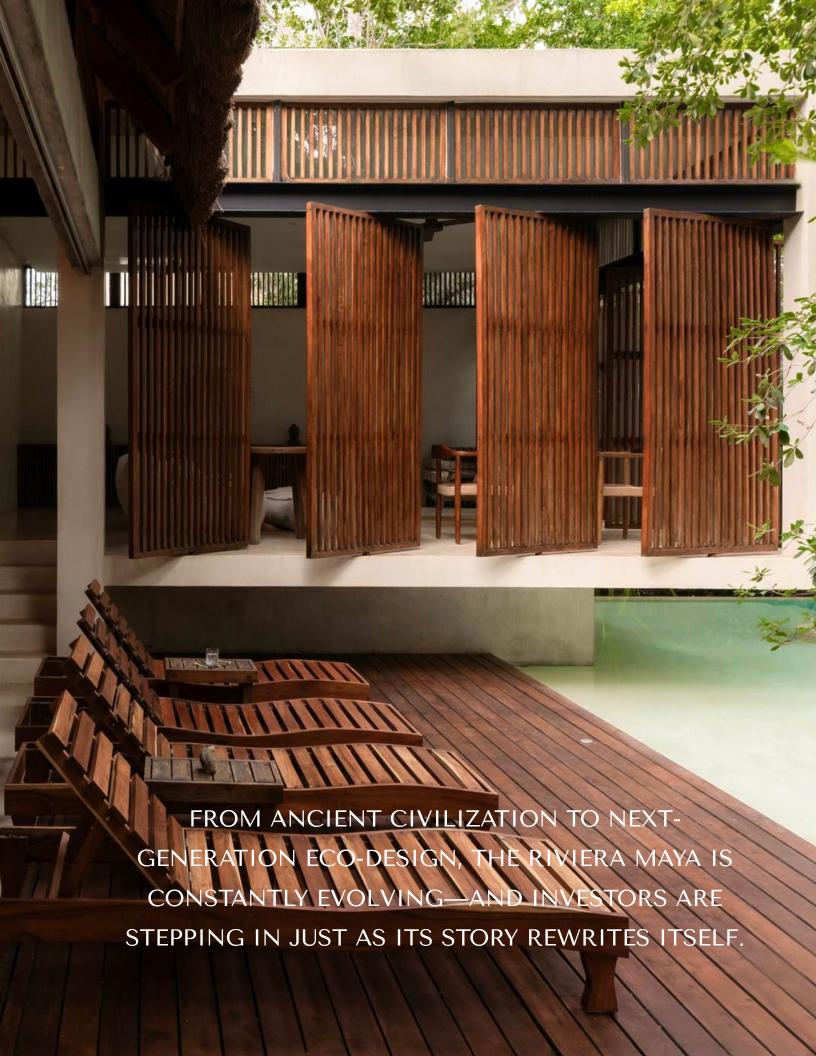
TULUM INTERNATIONAL AIRPORT

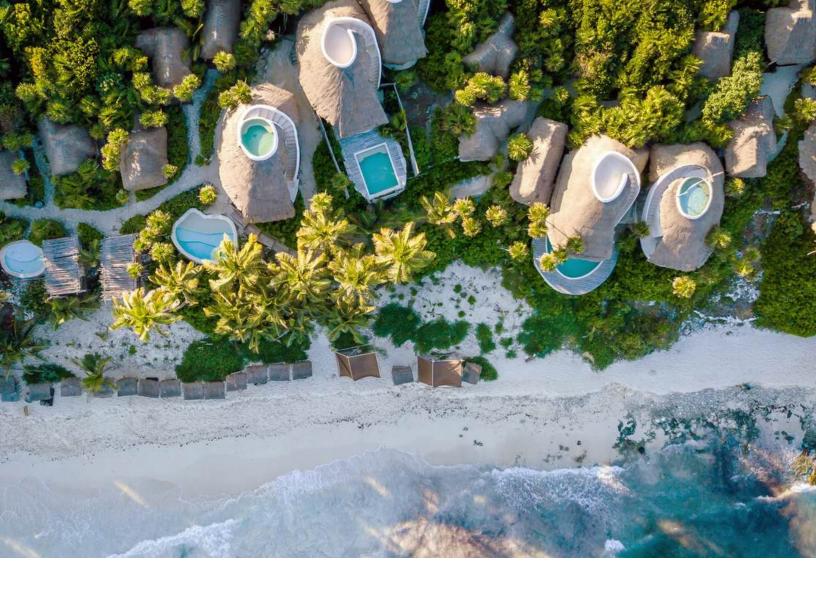
