ST. PETER THE APOSTLE TUITION ASSISTANCE FUND

The Jim & Lea Perlitz Scholarship Fund has been established through our capital campaign, and an average level of tuition assistance from this will be established as the fund matures.

HOPE FOR THE FUTURE

Hope for the Future is a tuition assistance program in the Archdiocese of San Antonio committed to raising money to offset the cost of tuition at Catholic schools. Last year, Hope for the Future provided \$2 million in assistance to 1,653 students. Awards are typically slightly over \$1,000 per qualifying student. ADDITIONAL INFORMATION

All Financial Aid applications are submitted online through FACTS Management at the cost of \$45 per family. To be considered for tuition assistance at the campus level, all completed applications are due by March 1, 2025.

The tuition assistance funds available through Hope for the Future and St. Peter the Apostle are designed to offset the cost of tuition, but they will not cover the full cost. However, many families find that they are able to fund their child's education through the support of grandparents, relatives, etc. We encourage families to apply for the available tuition assistance opportunities but also to explore opportunities for support within their community.
