Audition Requirements: Dancers must be enrolled in the following required courses: Ballet, Jazz, and one Elective class. Electives include: Tap, St. Funk/Hip Hop, Modern, Pre-Pointe/Pointe, Lyrical, Irish Step. The required curriculum will be mandatory for all company members to ensure that dancers are continuously training and strengthening their bodies, refining their technique, and are studying a well-rounded curriculum of dance. It is highly recommended that Company dancers take two ballet classes per week.
