- 10:45 AM: First look (15 minutes)
- 11:00 AM: Ceremony at a scenic location (10-30 minutes)
- 11:30 AM: Couple portraits at the ceremony location (1 hour)
- 12:30 PM: Light picnic or adventure (1 hour)
- 1:30 PM: Second portrait location or candid moments (1 hour)
- 2:30 PM: Coverage ends

4 HOUR TIMELINE

IDEAL FOR

- Simple Ceremonies
- Couples looking for minimal photo coverage
- Locations close to your starting point

4 HOUR EXAMPLE TIMELINE

- 1:00 PM: Getting ready and detail shots (30 minutes)
