

## LIABILITY FORM

In exchange for participation in equine-facilitated learning, groundwork, grooming, observation, and/or riding activities (collectively, the "Activity"), organized by The Hoof Equine-Facilitated Learning Center, operated by Robyn Jackson, located at 12950 Molly Berry Rd, Upper Marlboro, MD 20772 ("Releasee"), I hereby agree as follows:

- 1. I and anyone claiming on my behalf release and forever discharge Releasee and its affiliates, successors and assigns, officers, employees, representatives, partners, agents, and anyone claiming through them (collectively, the "Released Parties"), in their individual and/or corporate capacities, from causes of action or any nature and kind, known or unknown, which I may have against Releasee or any Released Parties arising out of or relating to any injury, loss, or damage to person and property that may be sustained as a result of participation in the Activity ("Claims").
- 2. I understand and expressly agree that this Release includes the release of liability for ordinary negligence of the Released Parties. I understand that participation in the Activity involves inherent risks, including risk of physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent paralysis, and/or death, and I assume all related risks and voluntarily participate in the Activity.
- **3.** I agree to indemnify Releasee against any and all claims, actions, lawsuits, damages, and judgments, including attorney's fees, arising out of or relating to my participation in the Activity.
- **4.** This Release for Participation in Event or Activity ("Release") shall not be in any way construed as an admission by the Releasee that it has acted wrongfully with respect to me or any other person, that it admits liability or responsibility at any time for any purpose, or that I have any rights whatsoever against the Releasee.
- 5. This Release shall be binding upon the parties and their respective heirs, administrators, personal representatives, executors, successors, and assigns. I have the authority to release the Claims and have not assigned or transferred any Claims to any other party. The provisions of this Release are severable. If any provision is held to be invalid or unenforceable, it shall not affect the validity or enforceability of any other provision. This Release constitutes the entire agreement between the parties and supersedes any prior or written agreements concerning the subject matter of this Release.
- **6.** This Release may not be altered, amended, or modified, except by a written document signed by both parties. The terms of this Release shall be governed by and construed in accordance with the laws of the State of Maryland.
- 7. Photo and Media Release (Optional): I acknowledge that photographs and/or video recordings may be taken during participation in The Hoof's activities.

I CONSENT to The Hoof and its representatives photographing or recording me (and/or my child, if applicable) for use in marketing, educational, or promotional materials, including social media and websites.
I DO NOT CONSENT to being photographed or recorded. I understand that declining consent will not affect my ability to participate in activities.
