## **Pricing and Payments**

All prices are in euros (€) and include VAT, unless otherwise stated. MOÏAÉ reserves the right to change prices, but you will be guaranteed the price in effect at the time of your order or appointment. Payments can be made using the payment methods offered on our website and in the salon. You are obliged to follow the payment instructions carefully.

## **Shipping and Delivery Times**

# **Return and Cancellation Policy**

Due to the hygienic nature of our products, custom-made hair extensions are non-returnable. For products that can be returned, the following conditions apply:

-Products must be unopened, unused and undamaged in their original packaging.

-Returns must be requested within 14 days of receiving the order.

Only the following items may be returned:

-Shampoos and other sealed hair care products

-Hair tools (e.g., hair dryers, straighteners, curling irons)

-Accessories such as brushes, combs, clips, and other non-hygienic items

All items must be returned in their original, undamaged packaging, with hygiene seals intact (if applicable). Products that are used, opened, damaged, or not returned in their original condition cannot be accepted for return.

The return shipping costs are the responsibility of the customer, unless the product is defective or an error occurred on our part. Refunds will be processed within 14 days of receiving the returned goods, provided they meet the conditions outlined above.

For cancelling an appointment in the atelier, we recommend doing so at least 48 hours in advance. This can easily be done via email or phone. Otherwise, the full amount of the advance payment will be retained and will not be refunded.
