<p>Registered Nurse Obstetrics Per Diem - Nights</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. license. Six months recent experience in perinatal nursing preferred. BLS and successful completion of neonatal resuscitation within six months of employment. Position Responsibilities: The staff nurse in Obstetrics functions independently in performing the nursing process through assessment, planning, implementation and evaluation of safe therapeutic care for all patients during labor, deliver, immediate post-partum and newborn care; including those patients in complex situations with overt and covert needs and/or complications of treatment during his/her shift. The staff nurse manages and coordinates the clinical activities on the patient unit during his/her shift.</p>
<p>Registered Nurse Intensive Care Unit Full Time/Per Diem</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. License. BLS and ACLS certification required within six (6) months. Minimum of one (1) year critical care experience within the last three (3) years required. Satisfactory completion of a course in critical care, intensive care or coronary care within the last three (3) years preferred. Position Responsibilities: Function independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment on his/her shift. The staff nurse manages and coordinates the clinical activities on the patient unit during his/her shift.</p>
<p>Registered Nurse Med/Surg Full Time Night Shift</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California RN License and BLS required. Minimum of one (1) year acute care experience within the past three (3) years preferred. Position Responsibilities: The staff nurse in the Med/Surg Unit functions independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment on his/her shift. The staff nurse manages and coordinates the clinical activities on their patient assignment and may be assigned to coordinate the unit activities during his/her shift.</p>
<p>RNFA Surgery Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California RN License and ACLS required. Successful completion of an approved RNFA course of instruction and proctoring criteria met is required. Minimum of two years perioperative experience is preferred. Position Responsibilities: The RNFA renders direct patient care as part of the perioperative team by functioning as a first assistant under the supervision of a surgeon with active privileges at Fairchild Medical Center.</p>
<p>Medical Lab Technologist - CLS Laboratory Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California Department of Health Services Clinical Laboratory Scientist License required. One (1) to three (3) years' experience preferred. Position Responsibilities: Performs all Laboratory test necessary for the diagnosis and treatment of patients at the request of the attending physician(s). Responsible for reporting accurate results substantiated by the use of appropriate controls. Demonstrates proficiency and understanding of routine procedures for all areas of the clinical laboratory with minimal supervision.</p>
<p>Speech/Language Pathologist Rehabilitation Services Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Licensed or License eligible as a Speech/Language Pathologist in the State of California. Successful completion of CFY under the supervision of a Speech/Language Pathologist. Position Responsibilities: Responsible for organizing, conducting, and developing a medically prescribed program of speech therapy within both hospital and outpatient settings.</p>
<p>Registered Nurse Emergency Department Full Time - Nights</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California R.N. License. BLS and ACLS certification required within three (3) months. PALS, TNCC, MICN preferred. Minimum of one (1) year acute care experience within the last two (2) years preferred. Six (6) months recent experience in Emergency department desirable. Position Responsibilities: The staff nurse in the Emergency Department functions independently in performing the nursing process through assessment, planning, intervention and evaluation of safe therapeutic care for all patient's overt and covert needs and/or complications of treatment in the Emergency Department. Manages and coordinates the clinical activities in the department during his/her shift.</p>
<p>Family Nurse Practitioner FM Clinic Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Master's Degree, and California Family Nurse Practitioner license required. BLS required. Position Responsibilities: In collaboration with a Physician, perform assessments and diagnosis, initiate treatment and /or therapy. Take patient history and perform physical examinations.</p>

<p>Physician Assistant Emergency Department Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Bachelor's degree and California Physician Assistant license required. BLS, ACLS, PALS required. ATLS (once, within six months) required. Position Responsibilities: In collaboration with a Physician, perform assessments and diagnosis, initiate treatment and /or therapy. Take patient history and perform physical examinations.</p>
<p>Registered Pharmacist Pharmacy Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Current California Pharmacy license required. Position Responsibilities: Compounds and dispenses medications by means of standard physical and chemical procedures to fill written medication prescription requests issued by qualified prescribers.</p>
<p>Certified Nursing Assistant/Ward Clerk Med/Surg Full Time/Part Time, Non Benefited Available</p>	<p>Required Education, Licenses/Certifications, and Experience: High School Education or GED equivalent required. Current CNA Certificate required. BLS required within three (3) months of employment. Position Responsibilities: The Ward Clerk/Nursing Assistant performs various clerical duties and related and non-professional services necessary in caring for personal needs and comfort of patients. Assists in the maintenance of a safe and clean environment.</p>
<p>Shift Supervisor Nursing Administration Part Time, Benefited</p>	<p>Required Education, Licenses/Certifications, and Experience: Current CA RN License required. BLS, ACLS required within three (3) months. Position Responsibilities: The shift supervisor coordinates the delivery of patient care for all nursing departments in the hospital. They are responsible for providing adequate staffing, within the budgeted FTE's to the various nursing departments. They act as a resource and provide direction to all nursing staff.</p>
<p>Clerk Rehabilitation Services Part Time, Benefited</p>	<p>Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalent required. Basic typing and computer skills required. Position Responsibilities: A member of the Front Office Team who assists in the processing of patients as they enter and leave the office, as well as organizing charts, filing various information and answering the telephone.</p>
<p>Sterile Processing Tech Central Supply Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalent required. Basic office skills required. Medical Terminology, ability to write legibly, spell correctly and perform basic mathematics required. Position Responsibilities: The Sterile Processing Technician is responsible for sterilization and provision of medical supplies and equipment to various department in the Hospital.</p>
<p>Admitting/PBX Clerk Admit/PBX Per Diem</p>	<p>Required Education, Licenses/Certifications, and Experience: High School diploma or GED equivalent required. Previous clerical experience and basic computer entry experience required. Knowledge of medical terminology and filing techniques required. Position Responsibilities: Operate switchboard terminal in conjunction with telephone and paging systems. Interview patients or patients' representatives. Computer data entry of patient and billing requirements.</p>
<p>Quality Care Specialist Nursing Administration Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Current CA RN License required. Minimum of 2 years acute care clinical experience required. BSN, 2 years of leadership experience, policy writing experience preferred. Position Responsibilities: This position will Analyze data to develop plans to improve patient care, and lead an interactive Performance Improvement (PI) team. They will interact and build relationships across the organization. This position will also report Quality Initiative findings (Core Measures, HCAHPS, etc.,).</p>
<p>Med Surg/OB Manager Nursing Administration Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Current CA RN License required. Minimum of 2 years acute care clinical experience required. BSN, 2 years of leadership experience, policy writing experience preferred. Supervisory experience highly preferred. Position Responsibilities: This position will coordinate patient care for Med-Surg and Obstetrics departments. They will be responsible for validating competencies, and act as a resource and provide direction for all Care Providers. They will develop standards of care for Med-Surg and OB patients, as well as monitor work volume, equipment, resources and staffing within the department, and comply with Title 22 and Joint Commission standards of care.</p>

<p>Registered Physical Therapist Rehabilitation Services Part Time, Benefited</p>	<p>Required Education, Licenses/Certifications, and Experience: Licensed as a Registered Physical Therapist with the State of California, or receipt of License Applicant Status letter from the Physical Therapy Board of California required. BLS required. Position Responsibilities: Responsible for organizing, conducting and developing a medically prescribed program of physical therapy in both hospital and out-patient setting.</p>
<p>Physical Therapy Assistant Rehabilitation Services Full Time</p>	<p>Required Education, Licenses/Certifications, and Experience: Licensed, or License Eligible as a Physical Therapy Assistant in the State of California. CPR Required. Position Responsibilities: A licensed health professional who conducts medically prescribed rehabilitation techniques as prescribed by a registered physical therapist.</p>
