



Compete in our Pre-liminary event to see who goes on to take part in the 3rd annual Berry Idol for the 86th West Tennessee Strawberry Festival. Prelims take place on February 10, 2024 in Humboldt at Magnolia Manor. Participants will be broken up in to two groups that will compete in two sessions, the first beginning at 10:00am then followed by the second group at 1:30pm. 15 performers will be selected to go on to compete in the official competition that takes place on May 7th, 2024. Upon meeting all registration requirements participants will be notified on or before February 7th as to which group they will compete in for the Preliminary event(morning or afternoon group). All contestants must compete in the preliminary in order to move on to the finals.

- Entries limited to Vocal Solo and Vocal Duets
- Vocal Solo or Vocal Duet is described as either a performance by an individual vocalist or maximum of two vocal performers. No vocalist may play any musical instrument during the vocal performance. The test shall be whether the performance would stand alone if the accompaniment were removed.
- Max of 1 Instrument(all sounds must be created live on stage)
- Percussion instruments must be a cajon or something with no set up time
- Accompaniment tracks with vocal utterances prohibited (this includes recorded live voices and voices that are produced and recorded synthetically)
- Performances limited to 3 minutes in length – any act running over will be disqualified. An act is timed from the first vocal utterance.
- Instrumental tracks must be delivered by **February 2nd** as an MP3 – downloaded on to a thumb drive (must be labeled with name of contestant) and will be returned upon conclusion of contest – Humboldt Chamber of Commerce 1200 E Main
- Entries limited to ages 10-21 – all contestants must be 10 years of age by the time of the contest, and no more than 21.
- **Open to the first 50 paid entries**
- Fee due at time of registration (non refundable, 3% fee added to card payments)
- MidSouth Fair Qualifier
- \$850 in prize money given away
- Prize money awarded to 1st, 2nd & 3rd Place
- Contestants may compete in only ONE category (either solo or duet)
- Entry fees: Vocal Solo \$40/Vocal Duet \$50
- Preliminary and Finals Round hosted at Magnolia Manor – 1424 E Main Street Humboldt, TN 38343
- FINALS will be held May 7th beginning at 6:00pm.
