141 families received Christmas assistance



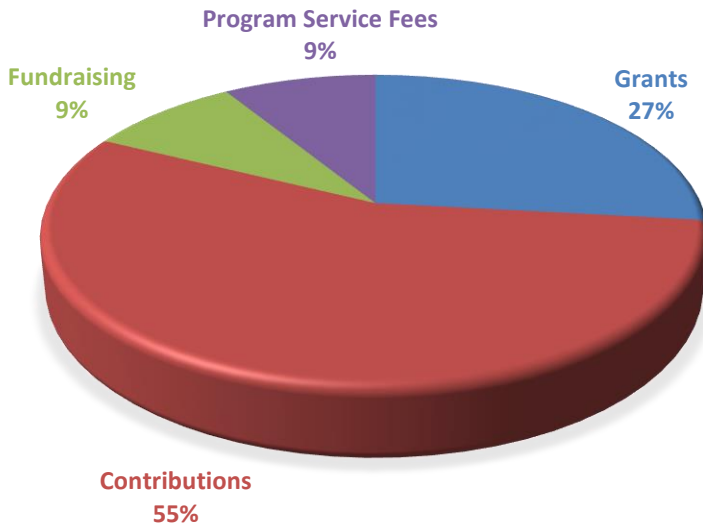
22 children enrolled in **Preschool**

2,900 volunteers provided over **10,000** volunteer hours

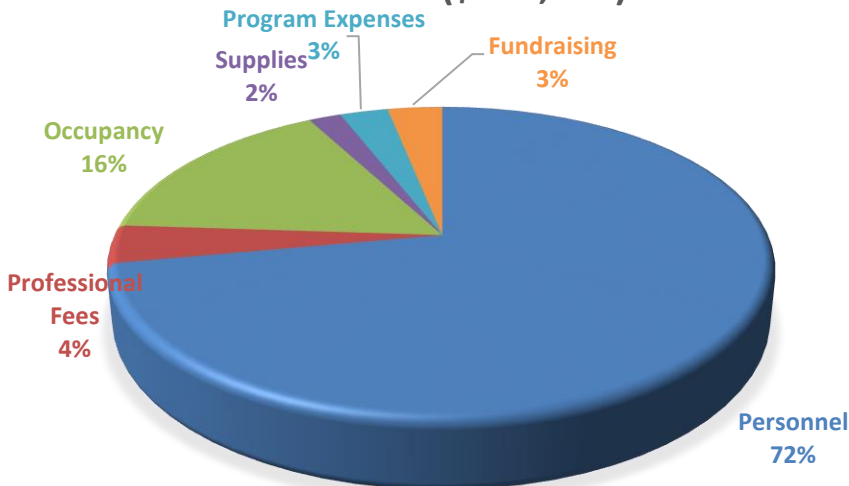


2017 Financials
