709.01 INTENT:

It is the intent of this chapter to regulate, restrict and control merchandise sales conducted on premises within districts of the Municipality which are zoned or properties whose primary occupancy is residential.

709.03 DEFINITIONS:

For the purpose of this chapter, Home Sales means a sale of personal property to the general public from any portion of a residence property within a district of the Village which is zoned residential or properties whose primary occupancy is residential and including, but not limited to, Garage Sales, Yard Sales, Rummage Sales, Patio Sales, Basement Sales, Porch Sales and the like.

709.04 FREQUENCY, LENGTH, HOURS:

(a) No home sale shall be conducted by the same person or persons, group, club, or organization or at the same location, more than (3) three times in a (12) twelve month period by the same household.

(b) No home sale shall be conducted for more that (3) three consecutive days except for the sale being conducted on Labor Day.

(c) Home sales shall not commence before sunrise and must be terminated by sunset.

(d) All merchandise offered for sale shall be removed from outside display immediately. Any merchandise so displayed on subsequent days after the expiration of the permit shall be considered in violation.

709. (d) SIGNS:

(d) Home sales signs may be displayed one day prior to the home sale which they advertise, and during the home sale, but must be removed within (24) twenty-four hours of the end of the home sale.

PERMIT:

Application for such permits shall be submitted to the Village Clerk and must be approved by the Manager prior to issuance after a fee of for sale, date of sale and hours of duration of sale. (5.00) five dollars is paid. Such application for permit shall include the name of the applicant who shall be a resident of the Village, address, telephone number, nature of merchandise to be offered for sale, date of sale and hours of duration of the sale. A permit must be obtained for each home sale conducted within the regulations of this chapter with the exception of Labor Day Weekend.

(a) A temporary sign that is approved pursuant to this section may only be displayed on the premises to which the sign is applicable. Unless otherwise specifically authorized by these regulations or by the Zoning Inspector, only (1) one sign may be displayed per business or residence at any time.

(e) Temporary signs shall NOT be attached to trees or utility poles or placed in a position that would obstruct or impair traffic or in any manner cause a hazard or disturbance to the health, safety, or welfare of the public. If placed on the side of a property where there is a sidewalk, the sign shall be located on the back side of the sidewalk (that is, on the opposite side of the sidewalk from the roadway). If placed on the side of a property where there is no sidewalk, the sign shall be located at least (8) eight feet from the edge of the roadway.

709.99 PENALTY:

Whoever violates any provision of this chapter is guilty of a Minor Misdemeanor. Any such violation shall constitute a separate offence on each successive day continued.
