Medical care that fits your budget

Summit Members choose an Unshared Amount of \$1,500, \$3,000, or \$6,000 (think "deductible") along with a corresponding Monthly Contribution (think "premium"). The higher the UA, the lower the Monthly Contribution.

For any of the above medical needs, Once your Unshared Amount is met, all qualifying medical expenses are shareable with the Summit community, with no annual or lifetime caps.

Maternity Sharing

Similar to other Sharing Requests, expectant mothers are responsible for a one-time Unshared Amount that covers all qualifying expenses associated with their maternity Sharing Request.

Eligible expenses may include miscarriage, hospital, homebirth, prenatal care, mother's complications, postnatal care, and delivery.



Prenatal & Postnatal Sharing Allowance

The following listed services are available with a \$5,000 sharing limit. We recommend collecting a prenatal and postnatal prepayment package from your clinician.

Prenatal

- · Routine office visits
- Routine lab work
- Doulas
- Midwives
- 2D, 3D, or 4D ultrasounds and more...

Postnatal

- Breast pumps
- Lactation consultant
- Postpartum counseling
- Acupuncture
- Chiropractic care and more...

Eligible delivery services

There is no sharing allowance or limit for delivery services.

- Hospital / Ob-gyn labor and delivery
- Cesarean
- Home births
- One in-hospital pediatrician visit includes routine immunizations, lab work, and hearing tests.

Reduction of UA Program for Maternity
Members with costs not exceeding \$10,000 for delivery, postnatal, and prenatal
expenses are eligible to reduce the Unshared Amount responsibility by \$1,000.

Preventive Care

These services do not require an Unshared Amount to be met.





Preventive Screenings

A variety of preventive and alternative screening methods for both men and women.



Doctor Visits

Sharing allowances available for PCP, specialist, holistic clinician visits.



Child Wellness Visits

Sharing allowances for additional child well visits.



Child Immunizations

Sharing allowances for recommended childhood immunizations.

Preventive Screenings

Each preventive screening is available with a Sharing Allowance at certain ages.





Cologuard

At age 45, members have a Sharing Allowance of \$681 for Cologuard once every 3 years.



Colonoscopy

At age 50, members have a Sharing Allowance of \$3,000 for a colonoscopy once every 5 years.



Mammograph & Thermography

At age 40, members have an annual Sharing Allowance of \$400 for mammography or thermography.

Office Visits

Each member receives four of the following types of visits each membership year with a Sharing Allowance of up to \$200 per visit. Family maximum of \$2,400 each membership year.





Holistic Clinician

Members may use alternative clinicians and holistic medical approaches for the office visit allowance.



Well-Women

An annual visit with an OBGY and the accompanying Pap test are included in the Sharing Allowance.



Doctor Visits

Office visits with a licensed physician are included in the Sharing Allowance. Additional items billed with an office visit are included in the office visit allowance.

Children

The following services have a Sharing Allowance associated.





Immunizations

The following childhood immunizations are available with a Sharing Allowance based on the CDC price list up to age sixteen.

Well Child Visits

The Preventive Sharing
Request Allowance for a child
well visit is up to \$200.
Additional visits are up
to age four.

How it Works

The process to share funds for these services can vary depending on the type of service, the provider, and your preference.





Instant Debit Card

Members can call and request an instant debit card to be emailed to pay for services in advance or at the time of service. Requesting selfpay discounts and providing a good faith estimate will help expedite the process and make you a savvy and responsible healthcare consumer.



Reimbursement

Members can pay for the service as a self-pay patient requesting applicable discounts. Open a Preventive Sharing Request and provide the itemized bill and payment receipt to Summit Healthshare.
