1. SERVICES PROVIDED

The Bridal Stylist agrees to provide the following services to the Client for the wedding on [Wedding Date]:

- Bridal Hair Styling
- Hair Trial Session
- Styling for [Bridesmaids/Family Members] (if applicable)
- Any other services as agreed upon: [List additional services, if applicable]

2. HAIR TRIAL

A hair trial will be scheduled on [Date of Trial] at Toppers Salon. The purpose of the trial is to finalize the desired bridal hair style. The Client agrees to communicate any preferences or ideas for the hairstyle during the trial.

The fee for the hair trial is \$75 and is due at the time of the trial. If the Client wishes to change the selected hairstyle after the trial, the Bridal Stylist may charge an additional fee for any extra styling or consultations.

3. SERVICE FEES AND PAYMENT TERMS

4. CANCELLATION POLICY

If the Client cancels the services within 30 days of the wedding date, the deposit will be non-refundable. If the Client cancels the services within 10 days before the wedding date, the full amount of the contract will be due.

5. TRAVEL FEES

If the event location is outside of Toppers Salon, a travel fee of \$1.00/per mile will apply, which will cover [travel costs, accommodation, etc.].

6. TIMING AND SCHEDULE

The Bridal Stylist agrees to arrive at [Venue or Client's Location] at [Time] to begin preparation. The Client agrees to provide adequate time for the stylist to complete the services. Any delays caused by the Client may result in an additional fee of \$[Amount] per hour.

7. CLIENT RESPONSIBILITIES

The Client agrees to provide accurate details regarding the desired style, and any preferences or requirements prior to the event. The Client also agrees to communicate any changes to the services agreed upon in advance.

8. LIABILITY

The Bridal Stylist will take reasonable care in providing the services but is not responsible for any allergic reactions, injuries, or damages arising from the use of beauty products or styling techniques.

9. PHOTOS AND MARKETING

The Client agrees that the Bridal Stylist may use photographs of the Client and the styling services for promotional purposes, including but not limited to social media, website, and portfolio materials. The Client may request that certain photos not be used, subject to prior agreement.

10. AGREEMENT AMENDMENTS

Any modifications or amendments to this agreement must be made in writing and signed by both Parties.

11. GOVERNING LAW

This Agreement will be governed by and construed in accordance with the laws of the State of New Hampshire.
