Every ECLT applicant must work with a participating lender to obtain mortgage pre-approval. Upon ECLT application, applicants will need a pre-approval letter **and** an initial loan application to apply. Every lender offers different loan terms and down payment assistance programs and are specifically trained in ECLT's affordable homeownership program and process.
