Upon winning the title of Miss Teen Rodeo Wisconsin, the winner and her parents or guardians must sign a contract for the annual commitment. ## General Rules

Contestants will check in at set times in the morning. They will be under supervision of Miss Teen Rodeo Wisconsin chaperones until they are checked out at the end of events. The chaperones or contestants will be escorted to and from all functions during those times.

Parents and supporters are welcome to attend all public events of the pageant, but may not have access to girls at certain events. (examples of events parents are not able to attend: All Interviews, Written Test, and Sponsor Visits)

A meeting of the parents, relatives, and friends will be scheduled on the first day of the pageant to explain the activities, rules, and answer any questions.

No gifts shall be given by any queen contestant to another queen contestant until all judging is over on Saturday afternoon.

Any complaints about the queen's contest, judges, other contestants, or anything relating to the pageant are to be referred in writing to the committee before the end of the pageant.

Judging will take precedence over all pageant activities. It will begin at the registration of the contestants and continue until coronation.

If there is only one contestant, the teen must score a 70% or higher overall to win the title and must score a 70% or higher in each category to win a category award.

After winning Miss Teen Rodeo Wisconsin, she may not compete in and/or otherwise participate in any other beauty contest, talent contest, pageant, and/or activity while holding the title of Miss Teen Rodeo Wisconsin.

MTRWI and contestants may not take any actions to cause harm to MTRWIPA.

## Contestant Eligibility

Each contestant in the Miss Teen Rodeo Wisconsin Pageant shall on the date of competition and final selection of Miss Teen Rodeo Wisconsin:

- Have obtained the age of 13 years and shall not have obtained the age of 20 years by the time of the 2027 pageant in August.
- Not be or have been previously married and/or pregnant.
- Be a resident of the state of Wisconsin, except in the case of parents living in different states, one parent or guardian's household must be in the state of Wisconsin, or if attending college out of state.
- Not be a title holder of any other pageant or national pageant.
- Have executed all consent forms and/or waivers of liability presented as conditions precedent to competition.
- Not be charged with and/or determined to have committed any crime of moral turpitude or cause damage to Miss Teen Rodeo Wisconsin Association.
- Abide by all rules and regulations of the Miss Teen Rodeo Wisconsin Pageant.
- Any contestant not meeting the qualifications set forth above shall be denied the right to compete in the Miss Teen Rodeo Wisconsin Pageant.

## Pageant Award Categories

### *Appearance*

- Proper fit of clothing
- Poise and posture – lady-like behavior in every situation
- Proper western attire and adhering to the dress code for each event
- Neatness and cleanliness in every detail including hands, fingernails, hair, hat, boots and clothing
- Contestants must wear long sleeve western shirts, pants, cowboy boots, cowboy hat, contestant banners, and belt for all appearances. The only exception is during the fashion show when young ladies will wear an outfit of their choosing that shows their style and personality.
- Contestants will wear two outfits during the fashion show. One, they will wear for a speech and modeling, for example dresses, suits, dress pants, shirt or skirt and long sleeve blouses. The second will be a fun fashion forward outfit. Both outfits will be worn with belt, buckle, boots, contestant banner, and cowboy hat.
- There should be no halter or prom type dresses. It is not acceptable to wear midriff or low-cut clothing and skirt length should be no more than 3 inches above the knee.
- See horsemanship portion for dress code for horsemanship.
- Any contestant dressed for a Queen function in attire other than what is called for in that specific category, will be penalized 10 points from each judge.
- **It is not necessary to invest in an excessive amount of expensive clothing. Judges will be looking for versatility and imagination displayed by the contestants.**

### *Personality*

Will be judged at every event except the written test and based on:

- Good common sense
- Maintain a good conversation in rodeo, agriculture, and other areas with special emphasis on grammar and enunciation
- Maturity, high moral standard, sincerity, integrity, self confidence without making an issue out of it
- Genuine interest in other people, the pageant, agriculture, and rodeo
- Promptness in keeping pageant schedule
- Self-projection - ability to project one's personality, whether it is from horseback in an arena or before an audience

## *Horsemanship*

Each contestant will have one go-round to select a young lady who:

- Has control of mount in any situation which may occur
- Proper position of hands, feet, and seat while riding, mounting, and dismounting
- Horsemanship will be judged on the contestant's ability to ride and knowledge of the horse. Not judged on the horse's ability or equipment.
- The judges will select one of the three patterns on the day of horsemanship. Each lady will run the same set pattern. Contestants will ride their own horse. Contestants may also be required to mount, dismount, carry a flag, do a presentation ride, and/or perform additional maneuvers on horseback. Any changes to horsemanship patterns will be made by judges and announced to the contestants before the horsemanship competition begins.

**Attire** – plain off the rack long sleeved, button up, collared, **white** western shirt (you may alter it to fit your body, but no dying or embellishments may be added to the shirt), off the rack jeans (no dying or embellishments added), boots, belt, and cowboy hat. Any accessories may be used (necklaces, wild rags, earrings, ect.) No vests, jackets, spurs, or chaps are allowed. All riding attire should be neat and fit properly. Showmanship should be considered since a contestant's personality does project from horseback to the audience and judges.

## *Knowledge*

Select the young lady who has the highest cumulative score in:

- Content of speech that relates to rodeo, western, or agriculture
- Knowledge of PRCA rodeo, sponsors, equine and current news discussed during the horsemanship interview
- Quality of answer to the two extemporaneous questions
- The young lady should understand rodeo, equine, animal welfare, agricultural topics, and current events.

## *Written Test*

- Each contestant will take a 100-point written test. The test can ask about PRCA events, equine and animal welfare, PRCA cowboys/cowgirls, and PRCA sponsors.

## *Photogenics*

- Photogenics is from the photograph submitted with the application in addition to the photoshoot that is done on the first day with all contestants and current Miss Rodeo Wisconsin and Miss Teen Rodeo Wisconsin.

## Judged Events

### *Speech*

- Each lady will give a 3 ½ minute maximum memorized speech.
- Topics are anything rodeo, western, or agriculture related. This can be a personal story/experience related to the topics mentioned.
- Judges will be made aware of the contestant's speech time. This will be done during the Fashion Show in your speech/modeling outfit.

### *Interviews*

#### **Personality:**

- Each contestant will be interviewed by the judges, privately. The basis of this interview will be to get to know the lady on an individual and personal level.
- The interview will be up to 15 minutes.

**Attire** - jeans or skirt, long sleeve button down collared shirt, vest, cowgirl hat, boots, buckle, belt, and contestant banner.

#### **Horsemanship:**

- Each contestant will be interviewed by the judges, privately. The questions asked will test the lady's knowledge of the pageant, PRCA rodeo, horsemanship, and current affairs.
- The interview will be up to 15 minutes.
- Understanding of basic horsemanship, equine science, rodeo events, and animal welfare.

**Attire** - blue jeans or dress pants, long sleeved button down collared shirts, jacket or vest, boots, belt, buckle, hat

### *Extemporaneous Questions*

- Two extemporaneous questions, personality based, will be asked of each contestant during the Fashion Show. The answers should be around 15-45 seconds long for each question.

## *Public Appearance*

- There will be one event in which the contestants will speak about the rodeo and pageant.
- Kid activities are done before each rodeo performance and contestants are expected to participate as a volunteer.
- Autograph Signing

## *Fashion Show*

- Contestants will wear two outfits during the fashion show. One, they will wear for speech and modeling, for example dresses, suits, dress pants, shirt, skirt or long sleeve blouses.
- The second will be a fun fashion forward outfit. Be ready to dance in this outfit.
- Both outfits will be worn with belt, buckle, boots, contestant banner, and cowboy hat.
- There should be no halter or prom type dresses. It is not acceptable to wear midriff or low-cut clothing and skirt length should be no more than 3 inches above the knee.

## *Program Ad*

- The 250-word maximum biography (written in 3rd person) submitted will be displayed in the program handed out during the rodeo performances.
- Will be judged on grammar and sincerity.

## Points

**Judging** – Judges will sign the score sheets in all categories, put them in a sealed envelope (furnished by the committee) and return to the committee immediately following each category. Awards will be handed out for each of the following categories: Appearance, Personality, Horsemanship, Knowledge, Written Test, Photogenics, and Congeniality. Points are distributed as follows:

## Waiver Agreement

THIS AGREEMENT is made between Miss Rodeo Wisconsin Pageant Association, Inc., St. Croix Valley PRCA Rodeo committee, City of Glenwood City, State of Wisconsin, hereinafter referred to as "Pageant" and \_\_\_\_\_, City of \_\_\_\_\_, Wisconsin,

hereinafter referred to as "Contestant".

WHEREAS, Pageant conducts the Miss Teen Rodeo Wisconsin Pageant (hereinafter referred to as "Contest"), including the creation, publication and administration of all rules and regulations relating thereto and WHEREAS, Contestant desires to compete in the contest, NOW THEREFORE, in consideration of the mutual promises set forth herein, the mutual benefits derived here from and other good and valuable consideration provided each unto the other, the receipt and sufficiency of which is acknowledged by delivery hereof, it is agreed:

1. Contestant represents she (a) has received a complete copy of all contest rules and/or regulations, (b) has read all contest rules and regulations, and (c) understands each and every rule and/or regulation, and (d) had full opportunity to present all questions regarding the rules and regulations, and all questions have been fully answered.
2. Contestant will adhere to and comply with all contest rules and regulations.
3. Contestant will upon observing and/or being informed of any violation of, and/or perceived violation of any contest rule and/or regulation:
  - a. Inform Pageant of the alleged and/or perceived violation, at the earliest and most proximate time to the instance, but in no event, not to be less than two hours of the scheduled naming of the contest winner(s) and
  - b. In no way act to withhold information from Pageant and/or from other third party contestant(s), as to deprive Pageant of the opportunity to determine alleged violations.
4. In this regard, Miss Rodeo Wisconsin Pageant Committee President is hereby designated as the person to receive any and all alleged and/or perceived rules violation(s).
5. Unless timely reported as defined above in paragraph 3 (a), each and every alleged violation of, and/or perceived violation of, contest rules and/or regulations shall be deemed waived, and the complaining party shall be stopped from presenting allegations regarding the same.

6. Pageant agrees that with respect to reported violation(s), it shall (a) timely and fully investigate each allegation, (b) report its findings to the person presenting the allegation and (c) enforce its rules and regulations against any contestant found to have violated the same.

7. Contestant agrees the Pageant is the sole and exclusive entity to determine the existence and/or nonexistence of a violation of the rules and regulations, and that Contestant shall be finally bound by Pageant's determination, the same to be final and binding between the parties hereto. Contestant further agrees that Pageant is the sole and exclusive authority to interpret and enforce its rules and regulations.

8. In any legal proceeding in which Pageant shall be awarded any judgment enforcing any term and/or condition of this Agreement, Pageant, its employees, agents, sponsors, and/or representatives shall also receive reasonable attorney fees and all costs incurred in the prosecution and/or defense of said action.

In consideration of my participation in the Miss Teen Rodeo Wisconsin Pageant, in accordance with the rules of such pageant, and for the other good and valuable consideration, the receipt of which is acknowledged, I, the undersigned consent, represent, warrant and agree to the following:

1. Age: Citizenship. I state that I am (a) over 13 years of age and legally authorized to execute this Release, and (b) a citizen or legal resident of the United States of America. I further state that all participant information stated below is true and correct.
2. Authorization to Use Images. I authorize Miss Rodeo Wisconsin Pageant Association, Inc. and their licensees, representatives, successors and assigns, (collectively MRWIPA) to use my name, voice, likeness, images or signature (collectively referred to as "Images") in any manner and in any medium and for any purpose which they choose, including without limitation print, radio, television, audio-visual recording, electronic or magnetic media, computer disks, computer file servers, CD-ROM's on the Internet, including the World Wide Web, or in any type of computer network or for advertising in or for any of those media. The Images used may include still images, motion pictures, videotape, audio-visual, live or recorded broadcasts. 

## Horsemanship Patterns


**Pattern #1**



### Horsemanship Pattern #1:

1. Extended jog along side of arena, then to center
2. Begin lope at center of arena and lope left circle on left lead
3. Change leads at center of arena and lope right circle on right lead
4. Change leads and continue loping around end of arena
5. Once on the straight, increase speed and continue around end of arena
6. Stop and back
7. The MRAP Judges reserve the right to make alterations and/or additions to this pattern.


## Pattern #2



### Horsemanship Pattern #2:

1. Circle the arena, on the left lead, at an extended lope.
2. Guide left and lope down the center of the arena with moderate speed.
3. Pass the center of the arena, stop and back to the center.
4. Execute a 3/4 turn to the right and lope a circle, to the right, with moderate speed.
5. Change leads and lope a circle, to the left, with moderate speed. After completing the circle, continue loping on the left lead toward the end of the arena.
6. Stop and pause to show completion of pattern.
7. The MRAP Judges reserve the right to make alterations and/or additions to this pattern.

## Pattern #3



### Horsemanship Pattern #3:

1. Circle the arena, on the left lead, at an extended lope.
2. Guide left and lope down the center of the arena with moderate speed.
3. Pass the center of the arena, stop and back to the center.
4. Execute a 3/4 turn to the right and lope a circle, to the right, with moderate speed.
5. Stop in the center, execute a 360 degree turn, to the left. Lope a small slow circle, to the left, followed by a larger, faster circle to the left. At the center of the arena, rate back to the slower speed and continue loping on the left lead toward the end of the arena.
6. Stop and pause to show completion of pattern.
7. The MRAP Judges reserve the right to make alterations and/or additions to this pattern.
