CLASS CHANGES EFFECTIVE JANUARY 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day.

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

FIX AND GO ON (FNG)

Fix and Go On will be offered. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

ENTERING FOR EXHIBITION ONLY (FEO)

For Exhibition Only will be offered. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in the all classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of any class. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
- Toys must be non-audible
- Toys may not leave the handler's hand
- Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

JUMP HEIGHT

MOVE-UPS and HEIGHT CHANGES No Text or Voice mail allowed for move-ups or class changes.

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary.

Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded. Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

Effective February 1, 2017:

Regulations for Agility Trials: Chapter 1, Section 21.

Change of Entry. In addition to Move-ups as described in Chapter 1, Section 20 entries may also be changed as noted in this section. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class. After the close of entries a dog may be moved down in their class level (i.e., Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

DOGS ELIGIBLE TO ENTER

This trial is open to purebred Shetland Sheepdogs 15 months of age and older that are registered with the American Kennel Club or have obtained an AKC ILP/PAL number. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) must be spayed or neutered in order to compete. Wherever the word 'dog' is used in these regulations it includes both sexes. Canine Partners are allowed entry into this set of trials.

HANDLER WALK-THROUGH, TIMING AND WARM UP

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog. Electronic timing devices may be used.

MEASURING and HEIGHT CARD INFORMATION

All agility dogs are required to have an Official Jump Height Card and exhibitors must be able to present it prior to running their dog(s) in any class or at any time during the trial upon request. Dogs without a valid Jump Height Card may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this

measurement will be valid for this trial or back-to-back trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

SITE INFORMATION

This trial will be held at Progressive School for Dogs, owned by Liz Blasio, private property which includes a dog boarding facility. Please observe the "Drive Slow" signage on the driveway, and walk and potty your dogs only in the designated areas to the East of the Agility Building. There will be indoor crating available in the lobby of the building, but no crating allowed on the artificial turf in the agility area

NOTICE TO EXHIBITORS

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. **Telephone, Telegraph, and Unsigned Entries** cannot be accepted. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement & Rules attached to the Official AKC entry form are NOT ACCEPTABLE.

Entries received without fees will not be accepted.

THE ASSA WILL ACCESSES A \$50.00 CHARGE, IN ADDITION TO ALL BANK FEES INCURRED, FOR ANY NSF CHECK OR ANY PAYMENT RETURNED FOR ANY REASON.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Express Mail entries must contain a signature waiver. No Refund for duplicate entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Errors on Entry Forms: Owners are responsible for errors in filling out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after published closing date.

Entry Fees: \$40.00 for the first entry of each dog (includes \$3.50 AKC Recording Fee for the 1st entry of each dog); \$25.00 for each additional entry of the same dog (includes \$3.50 AKC Recording Fee for additional entry of the same dog). **Make All Checks and Money Orders** payable to ASSA. Canadian Exhibitors must make fees payable in U.S. Funds. Payment must accompany entry. Trial Secretary assumes no responsibility for cash sent through the mail. Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. Those received by telephone are not acceptable.

All entry forms and payment checks that do not make the draw for the trial or do not move in to the trial will be shredded after the closing date unless otherwise requested.

Exhibitors should follow their veterinarians' recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Refunds due to miscalculation of fees is at the option of the ASSA.

Safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with, and are able to perform, all of the obstacles safely.

ALL DOGS MUST BE ON LEASH AT ALL TIMES except when in the ring or when in the designated warm-up area. It is expressly understood that the exhibitors alone are responsible for the behavior of their dog(s), guest(s), and children.

Any exhibitor whose dog(s), guest(s), and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of fees paid will be made. Parents are solely responsible for their children, and are expected to keep them supervised and controlled at all times for their own safety. No baby strollers in the show buildings.

UNENTERED DOGS MAY BE ASKED TO LEAVE THE SHOW SITE.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. Bitches in season are not permitted at the trial. Entry fees for bitches that come into season before these trials take place will be refunded provided the Trial Secretary receives notice from a veterinarian in writing prior to the start of judging on the first day of the trial. A \$10.00/day entered recording fee will be withheld for entries withdrawn due to a bitch being reported in season.

No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, violent acts of nature, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

The Show Site Committee reserves the right to alter crating arrangements for space purposes. Exhibitors are responsible for the conditions in and around their own crate.

No dogs will be permitted to stay overnight at the show site.

Please respect the grounds and clean up after yourself and your dogs!

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list.

Puppies under 4 months of age are strictly prohibited at AKC Agility Trials.

- *Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class, but do not receive the participation point as well. The participation point in performance events is awarded if the dog competes but does not qualify in the event.
- *Dogs competing in multiple classes at the same event (for example, Standard & JWW agility, Master & Premier agility, Open & Utility obedience) will be awarded points for the highest-level class in which they receive a qualifying score. Dogs will not receive points for qualifying in more than one class in any event.

*Dogs that make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same two points as dogs that make one cut.

*Dogs excused from the breed ring will still be awarded a point for participation. Dogs disqualified from the breed ring will not be awarded a point for participation.

*In the event of a tie, event scores will be used to break the tie. The dog with the highest total score will receive the award. HT & PT qualifiers do not receive a numerical score, so a score of zero will be used in calculating their total score.

A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.

After the close of entries a dog may be moved down in their class level (i.e., Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the trial secretary at least 30 minutes prior to the start of the trial.

If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.
