## PRE-EVENT CONSULTATION

At 1000 Reasons, every celebration begins with a relaxed, one-hour pre-event consultation designed to guide you through the possibilities and help shape an event that feels true to you.

During this consultation, we'll walk you through our venue spaces, discuss your vision, and explain what's included in your booking. We'll cover minimum spends, catering pathways, styling considerations, and the difference between shared space and exclusive use, so you can confidently choose the option that best suits your event, guest numbers, and budget.

This is a collaborative and informative session — a chance to ask questions, explore ideas, and understand how your celebration can come to life on our farm.

We highly recommend you bring along your ideas and photographic images from Pinterest or similar, ideas on food, or any budget constraints to help us create an accurate quotation for your celebration.

## OPTIONS TO CONSIDER

### Shared Space Options (up to 50 guests)

Shared space events are designed for smaller group gatherings and for those looking for a more budget friendly option. In a shared space you will have a designated area for your event but there may be others using the public spaces at the same time. These type of celebrations are ideal for birthdays, hens parties, baby showers, or any other celebration up to 50 guests

### Exclusive Venue Hire (up to 100 guests)

If you prefer more privacy to create an exclusive event utilising the entire venue, you can guarantee no other event will happen on the same day at 1000 Reasons.

This will give you, your guests, event coordinators, caterers and waiting staff full use of the entire venue from 12pm - 12 midnight on the day of your event.

This type of event is ideal for larger scale events like weddings or large corporate events & milestone occasions for up to 100 guests.

## TERMS & CONDITIONS

### Events at 1000 Reasons Echunga, Adelaide Hills, South Australia

The following Terms & Conditions apply to all events held at 1000 Reasons ("the Venue"). By confirming a booking, the Client agrees to be bound by these Terms & Conditions.

#### MINIMUM SPEND

A minimum spend applies to all event bookings.

The minimum spend includes:

- Venue hire fee
- Ice, Napkins & Basic Table Linen
- Bar Staffing provided by 1000 Reasons
- Venue Tables & Chairs

The minimum spend does not include:

- External catering or food vendors
- Beverage Packages
- Security personnel (if required)
- Entertainment, PA equipment & staging.
- Transport, delivery or accommodation costs
- Additional tables & chairs or catering equipment
- Additional crockery, cutlery & glassware.

Minimum spend requirements will be clearly outlined in your event proposal.

#### TENTATIVE BOOKINGS & CONFIRMATION

Tentative bookings are held for 7 days without obligation.

After this period, the booking will automatically lapse.

To confirm and secure a booking, the following is required within the 7-day hold period:

- A signed Event Booking Confirmation
- Payment of a non-refundable deposit of \$1,000

Bookings are not confirmed until both items are received.

#### INVOICING & PAYMENT SCHEDULE

##### 1. Deposit Invoice

A non-refundable \$1,000 deposit is required to secure your event date.

##### 2. Pre-Event Invoice (Final Payment)

The remaining balance of the estimated total spend is payable 30-days prior to the event date (timing may vary depending on the event).

This invoice is based on:

- Guest numbers
- Selected beverage packages
- Venue hire duration and spaces

Once issued, this amount becomes the minimum event value.

##### 3. Additional Invoices

Any approved changes after final invoicing (including increased guest numbers, extended hours or additional services) will be invoiced separately and must be paid prior to the event.

#### PAYMENT METHODS

Payments may be made via:

- Cash
- Bank transfer
- Credit card (1.6% merchant fee applies)

Payment details will be provided on your invoice. All payments must be received by the due date to ensure your event proceeds as planned.

#### CANCELLATIONS & REFUNDS

All cancellations must be made in writing.

- 6 months or more prior to the event: Deposit forfeited
- Less than 6 months prior to the event: All payments forfeited

Deposits and payments are non-refundable and non-transferable.





## TERMS & CONDITIONS

### PRICING & SURCHARGES

- A 20% surcharge applies on public holidays and the Friday, Saturday and/or Sunday adjoining them
- All pricing is subject to change without notice until a booking is confirmed along with the paid deposit.

### FOOD & CATERING

1000 Reasons allows clients the flexibility to choose from approved external catering partners.

All catering vendors must:

- Be approved by 1000 Reasons
- Hold appropriate catering licenses and Public Liability insurance.
- Comply with venue guidelines and bump-in/bump-out times

No BYO food or beverages are permitted, with the exception of celebration cakes.

Celebration cakes incur a cakeage fee of \$50/cake.

### BYO ALCOHOL

BYO alcohol is strictly prohibited.

Any guest found bringing alcohol onto the premises will be asked to dispose of it immediately or leave the venue.

### TRANSPORT & PARKING

Parking at the venue is limited to 40 cars. We strongly recommend organising guest transport, particularly for evening events.

- Vehicles may not be left overnight without prior approval
- All vehicles must be collected by the agreed time at the conclusion of the event
- 1000 Reasons accepts no responsibility for vehicles onsite

### SMOKING & VAPING

1000 Reasons is a smoke-free property, however a designated outdoor smoking area will be nominated. Smoking and vaping are not permitted outside this nominated area.

### EVENT CONFIRMATION & GUEST NUMBERS

- Final event details and supplier contacts are due 1 month prior
- Final guest numbers are due 2 weeks prior

No refunds apply for reductions in guest numbers after this time. If attendance exceeds confirmed numbers, additional charges will apply and must be paid immediately.

### FIRE SAFETY & TOTAL FIRE BAN DAYS

On days of Total Fire Ban:

- Smoking and sparklers are prohibited
- Additional safety measures may apply

In the event of a catastrophic fire rating requiring cancellation or evacuation, 1000 Reasons will assist with rescheduling where possible.

### BEVERAGE PACKAGES

- Beverage selections must be confirmed 30-days prior
- All beverages remain the property of 1000 Reasons
- Beverages may not be taken offsite

Any beverages consumed outside agreed service times may be charged at retail rates.

### RESPONSIBLE SERVICE OF ALCOHOL & ILLICIT DRUGS

1000 Reasons operates in accordance with RSA regulations and SA Liquor Licensing Laws.

We reserve the right to:

- Refuse service to intoxicated guests
- Request proof of age
- Decline service where required to ensure public safety

Alcohol will not be served to persons under 18-years of age.

The use, possession or distribution of illicit drugs is strictly prohibited on the property. Any person suspected of being under the influence of illicit substances will be required to leave the premises immediately and will immediately be refused service.





## TERMS & CONDITIONS

### CLEANING & DAMAGE

Standard cleaning is included in your venue hire.

Additional charges may apply for:

- Excessive dirtiness left by catering or guests, charged at \$250.
- Damage to buildings, grounds, furniture or equipment
- Damage caused by guests, suppliers or contractors

The following are not permitted:

- Wax candles
- Confetti, glitter, table scatters or party poppers

Rubbish must be removed at the conclusion of the event unless otherwise agreed. Additional removal fees may apply.

### SECURITY BOND

In addition to the booking deposit, a security bond of \$1,000 is required (via cash or bank transfer) and will be held until two 2-days after the event. Following a post-event inspection, the bond will be refunded in full to your nominated bank account (or cash to be collected), provided no damage or excessive cleaning is required. Should any breakages or minor damage occur, costs up to the value of the bond (including glassware, crockery or incidental damage) will be deducted, with the remaining balance returned to you. If repair, replacement or labour costs exceed the bond amount, an additional invoice will be issued accordingly, with 7-day payment terms.

### ACCEPTANCE OF TERMS

By confirming a booking, the Client acknowledges they have read, understood and agreed to these Terms & Conditions.
